**SECTION 2. QUESTIONS, RESPONSES AND CLARIFICATIONS**

<b>Question 1:</b>	Our UHP trucks only carry 1600 gallons of water, and will have to drain and fill one a night, will this be acceptable?
<b>Answer 1:</b>	<b>Yes, that is acceptable.</b>  <b>Section 5.14.2.4 is hereby deleted and revised in its entirety as follows:</b>

**"5.14.2.4 Water Flushing Truck**

**There shall be no minimum capacity of water storage for the equipment, however Contractor must be able to meet the productivity requirements of Section 5.14.2.5 "High-Pressure Water System".**

**A constant water flow shall be provided regardless of truck speed to flush areas of Work, as directed by the Commissioner. The Flushing Truck shall be equipped with safety shields to protect other vehicles, aircraft or personnel from propelled debris."**
