SECTION I: REVISIONS TO THE SPECIFICATION

Specification is hereby amended as follows:

Revision 1:

Article 1.16 Submission of Bids: Submission of Bids is hereby being deleted in its entirety and replaced with the following to change the paper submission process:

Article 1.16.1 Deadline and Procedure for Submitting Bids:

 To be assured of consideration, Bids must be submitted electronically to the Department of Procurement Services no later than 11:00 A.M. Central Time on April 21, 2020. Bidder must submit all required information: Required Information by uploading as attachment(s) to the electronic BID submission in iSupplier.

Bidder must enter the Total Price in eProcurement where required.

"iSupplier" refers to the City's eProcurement computer system for electronic bidding and providing Contractors with access to contract, ordering and payment information for their City contracts.

iSupplier vendor portal registration is required. Allow three (3) business days to complete registration.

Article 1.16.2 Date, Time, and Place:

Bids are to be submitted electronically to the Department of Procurement on the date and prior to the time stated above, or any addendum issued by the City to change such Bid Due Date. No Bid will be accepted after the Bid Due Date. The time of the receipt of the Bid will be determined solely by the "Time of Quote" generated by the iSupplier system.

Article 1.16.3 Bids Must Be Submitted Electronically Through the iSupplier System:

All Bids must be submitted electronically through the iSupplier system. No paper solicitations will be accepted. Bid & Bond Room is closed and will not be accepting Bids.

Article 1.16.4 Bidders Are Responsible for Bid Submission:

Each Bidder is solely and completely responsible for submission of its Bid to the iSupplier system before the date and time established for the Bid opening. Any Bid that is not delivered on time, including Bids mistakenly delivered to other City offices, will not be accepted. The City is under no obligation to ensure that misdirected Bids are delivered to the iSupplier system prior to Bid opening.

Article 1.16.5 Transparency Website; Trade Secrets:

Consistent with the City's practice of making available all information submitted in answer to a public procurement, all bids, any information and documentation contained therein, any additional information or documentation submitted to the City as part of this solicitation, and any information or documentation presented to City as part of negotiation of a contract or other agreement may be made publicly available through the City's Internet website.

However, Bidders may designate those portions of a Bid which contain trade secrets or other proprietary data ("Data") which Bidder desires remain confidential.

To designate portions of a Bid as confidential, Bidder must:

- A. Mark the cover page as follows: "This bid includes trade secrets or other proprietary data."
- B. Mark each sheet or Data to be restricted with the following legend: "Confidential: Use or disclosure of data contained on this sheet is subject to the restriction on the title page of this bid."

Bidder is responsible for properly and adequately redacting any Data which Bidder desires remain confidential. If entire pages or sections are removed, they must be represented by a page indicating that the page or section has been redacted. Failure to provide a redacted copy may result in the posting of an un-redacted copy.

Revision 2:

Article 1.18 Bid Opening: Bid Opening is hereby being deleted in its entirety and replaced with the following to change the paper submission process:

Article 1.18.1 Bid Opening:

Bids will be opened and read out publicly immediately after the deadline for the submission of Bids has passed and will be made available in a live streaming YouTube video referencing

Specification 354609. Announcement of the Bids and the apparent low Bidder will be made in a live streaming YouTube video and are neither final nor binding. All Bids and Bid Documents

Addendum No. 8, Specification No. 354609, Tradesmen Services, Department of Water Management,

are subject to review by the Department of Procurement Services to determine the lowest responsive and responsible bidder and whether a contract will be awarded. Bid tabulations are public information and are posted on the City's website www.cityofchicago.org/BidTab.

Revision 3:

Cover page: Performance Bonds: Performance Bonds requirement indicated in the cover page of this Specification has been changed from "yes" to "no". There is no Performance Bond requirement for this Specification.

Revision 4:

Article 1.12.4 Performance and Payment Bonds: Performance and Payment Bonds language remains the same as in the original Specification.

Revision 5:

Article 4.7 Services and Supply Contract: New Article 4.7 is hereby added to the Specification:

Article 4.7 Services and Supply Contract

This Contract is a services and supply contract for future City needs arising over the duration of its term. It is not a contract for public works or public improvements. No particular work or improvement is contemplated as of the time this agreement is entered into, and there is no guaranteed amount or type of work that may be requested. Accordingly, the Public Construction

Bond Act (30 ILCS section 550/0.01 et seq), section 23 of Mechanics Lien Act (770 ILCS section 60/23), the Illinois Prevailing Wage Act (820 ILCS 130/.01 et seq.), and section 2-92-030 of the Municipal Code of Chicago, do not apply hereto by virtue of their terms.

Revision 6:

Article 5.5 Illinois Prevailing Wage Act/Davis-Bacon Act has been deleted in its entirety and replaced with the following language:

Article 5.5 Prevailing Wage

Contractor is required to treat all of the work under this Contract as being subject to payment of the Illinois Prevailing Wage. The City hereby requires contractors and subcontractors to pay laborers, workers and mechanics performing services under this Contract no less than the current "prevailing rate of wages" (hourly cash wages plus amount for fringe benefits) in the county where the work is performed.

The Illinois Department of Labor ("IDOL") publishes the prevailing wage rates on its website at http://www.state.il.us/agency/idol/rates/rates.HTM. IDOL revises the prevailing wage rates and the contractor/subcontractor has an obligation to check IDOL's web site for revisions to prevailing wage rates. For information regarding current prevailing wage rates, please refer to IDOL's website. All contractors and subcontractors rendering services under this contract must comply with payment of the prevailing wage rates. As a condition of making payment to the Contractor, the City may require the Contractor to submit an affidavit to the effect that not less than the prevailing hourly wage rate is being paid to laborers, mechanics, and other workmen employed on this Contract.

Revision 7:

Article 5.6 Labor Unit Price Adjustment: Labor Unit Price Increase has been deleted in its entirety and replaced with the following language:

Article 5.6 Labor Unit Price Adjustment:

Beginning on the date after the initial twelve (12) month term, and for each twelve (12) month anniversary thereafter, subject to acceptable performance by the Contractor and contingent upon the appropriation of sufficient funds for the procurement of the good and/or services provided for in this Contract, annual labor rate adjustments may be made after receipt of written request from the Contractor made no later than thirty (30) calendar days after the expiration of

each such twelve (12) month period. If Contractor does not request a price adjustment within such thirty (30) calendar day period, Contractor will not be entitled to a price adjustment for the upcoming year.

Unit Prices for IDOL trades named in this specification will be adjusted based on the change in the wage classifications and rates "current" at the time the Contractor requests an adjustment to specific Unit Prices, providing the request is made in writing, and is made AFTER the first twelve (12) months of the contract Period. If any of the Unit Price costs for: "BASE," FRMAN," "M-S>8," "OSA," "OSH," H/W," "Pensn," "Vac," or "Trng" rates change, the corresponding Unit Price affected by the rate change is adjusted by the same amount as the prevailing wage rate change. For example: if Prevailing Wage rates increased \$0.25/hour for a certain classification, the Contractor and City would increase that corresponding Unit Price rate by \$0.25/hour, subject to the below provisions, by executing a modification to the contract.

With respect to calculating the change in Prevailing Wage the Contractor will be allowed to add on changes for increase in fringe benefits as well. For example, if the Prevailing Wage increases .40 and the other benefits listed on the Prevailing Wage table increase an additional .08, the change to the rate would be based on .48 cents per hour.

Furthermore, the City will allow the Contractor to add up to an additional 25% to the change in the hourly rate (no rounding up) to account for increases in overhead cost. For example, if the Prevailing Wage increases of \$0.48 (inclusive of fringe benefits), the Contractor could request an overall increase of \$.60 based on \$.48 + (\$.48 X .25). The Contractor must provide a letter from their accountant attesting to what percentage the Contractor's overhead increased when requesting an increase in the overhead. In case overhead increased more than 25% according to the accountant, the Contractor will be limited to an overhead amount that equates to 25% of the increase in Prevailing Wage.

An adjusted Unit Price for labor will NOT become effective until after the initial twelve (12) month term of the contract has elapsed, and every twelve (12) months thereafter, in accordance with the terms and conditions of this Specification.

Changes in the fully loaded hourly rates will be retroactive to the effective date of the new Prevailing Wage.

The Contractor must provide supporting documents to verify the nature and cause for the change in the Unit Prices, and the effective date of those changes. Any Unit Price adjustment and the effective date for the adjusted Unit Price must be made in the form of a contract modification signed by the City and the Contractor before the Contractor can invoice the City at those adjusted Unit Prices. Consequently, the Contractor releases the City from any liability whatsoever to pay for services rendered at prices other than the Unit Prices contractually in effect at the time the services were provided. Unit Prices are considered contractually in effect upon the Contractor's receipt of the fully signed contract modification.

Revision 8:

New Article 5.6A, Price Adjustment for Apprentices: Price Adjustment for Apprentices, has been added as follows:

Article 5.6A Price Adjustment for Apprentices:

In recognition of the importance of providing work opportunities for apprentices, Contractor may utilize apprentices on appropriate work assignments with the consent of the applicable using Department. Apprentices will be billed at the percentage of the overall hourly rate on the contract as the worker is paid as an apprentice. For example, if the apprentice is being paid at 80% of Prevailing Wage, and the fully loaded hourly rate for that worker type is \$100, contractor would bill \$80 per hour for the apprentice.

Revision 9:

Article 4.4 Centralized Invoice Processing: Centralized Invoice Processing has been deleted in its entirety and replaced with the following language:

Article 4.4 Centralized Invoice Processing:

Invoices for over-shipments or items with price/wage escalations will be rejected unless the Contract includes a provision for such an adjustment.

Freight, handling and shipping costs are not to be invoiced; deliveries are to be made F.O.B., City of Chicago.

The City of Chicago is exempt from paying State of Illinois sales tax and Federal excise taxes on purchases.

The City may change its invoice submission and processing procedure during the term of this Contract. Should a change occur, the City will notify Contractor of the new procedure which the Contractor will then be required to follow.

Revision 10:

Article 5.21. Tools – Bid Line Item 22: Tools – Bid Line Item 22 has been deleted in its entirety and replaced with the following language:

Article 5.21. Tools - Bid Line Item 22:

Contractor must furnish, at no additional cost to the City, all tools under this Agreement that are to be reasonably expected to be utilized by the trade worker to a commercial/industrial work assignment for that particular trade and for the services described in this Agreement and any other tools in Contractor's inventory that are necessary for a job. In the case in which an unusual tool is required for a particular job that could not have been reasonably expected to be provided by the Contractor for the work contemplated herein ("Non-Typical") and is not otherwise in Contractor's inventory, Contractor may request that the City provide such Non-

typical item (under an existing City contract or inventory), or if not available from the City, then request that the City pay the rental cost of such Non-Typical tool. The Commissioner of the particular department for which the job is being done shall determine, based upon written submissions provided by the Contractor, whether the Commissioner agrees that such tool is Non-Typical. i.e., (i) is required for a particular job and (ii) could not have been reasonably expected to be provided by the Contractor. If the Commissioner, in the Commissioner's sole discretion, agrees with such request, the Non-Typical tool may be obtained by the Contractor from some other resource and charged to the City at rental prices no greater than the rental prices as published in the **Tool and Equipment Rental Rate Guide published by MCAA** as such price is discounted or marked up by the percentage of bid on

Line 22 of the Proposal Pages. NOTE: Tool and Equipment Rental Rate Guide published by MCAA is provided for price reference only, therefore none of the terms and conditions apply to this Contract.

For example: A Plumber may need Non-Typical tools for a job. If determined by the Commissioner to be Non-Typical and approved by the Commissioner as necessary, then the Non-Typical tools, if further unavailable from the Contractor's inventory or the City, could be rented from a third party and charged to the City at prices no greater than the prices published in the then current Tool and Equipment Rental Rate Guide published by MCAA, as such price is discounted or marked up by the percentage of bid on Line 22 of the Proposal pages. Rental of such equipment must be at the most economical of daily, weekly, or monthly rates as applicable to each work assignment (and in consideration of work assignments being efficiently scheduled so that the rented piece can be used concurrent with or subsequent to an existing work assignment). For tools which have a consumable aspect such as saw blades, grinding wheels, abrasives, drill bits, rodder tips, the City will either provide the consumables to the Contractor or allow the Contractor to provide under Parts (BID LINE ITEMS 21, 169-173) provided the Contractor returns the consumable item to the City after it has been fully utilized. The Commissioner will determine whether to provide or to allow the purchase pursuant to the stipulations in the "Parts" Section below. Failure to return spent consumables to the City will result in a deduction from the Contractor's invoice based on the cost being charged to the City if the Contractor provides the consumable or the City's cost for the consumable in the event the City provides the consumable.

Revision 11:

Article 5.21A. Mark-Up Over Contractor Cost: Mark-Up Over Contractor Cost has been deleted in its entirety and replaced with the following language:

Article 5.21A. Mark-Up Over Contractor Cost:

Any Non-Typical tools that cannot be provided by the City, or Contractor from its own inventory, and are not listed in the **Tool and Equipment Rental Rate Guide published by MCAA** may be charged to the City at no greater than the Contractor's actual net cost of rental plus 5%. The Contractor must use its best efforts to obtain no less than three (3) quotes from qualified providers, (where the request for quote is presented to each provider under the same terms and conditions to rent the same tool, in the same quantity, and within the same delivery time). The Contractor must then provide such Non-Typical tools to the City at the lowest of the obtained quotes, and maintain complete records of all such transactions, in an organized and professional manner, such records are subject to audit by the City, in accordance with the Audit clause of Section 3.2.1.7 in this specification. Rental of such tools must be at the most economical of daily, weekly, or monthly rates as applicable to each work assignment (and in consideration of work assignments being efficiently scheduled so that the rented piece can be used concurrent with or subsequent to an existing work assignment). The quotes obtained by the Contractor as well as a copy of the Commissioner's approval to provide the rented tools must accompany the Contractor's invoice to the City. Such rental will be subject to the

percent (10%) of the original value of the Contract limitation set forth in Section 4.1.3 (Unspecified Items/Services). A line will be added to the Contract purchase order before Contract award to facilitate purchases under this Section. Contractor must cooperate with the City to process on an annual basis a reconciliation modification that includes all rentals made under this Section 5.21A in the preceding year.

Revision 12:

Article Allowance for Premium for Off-shift Work (Line Item 178): A new Article 5.35, "Allowance for Premium for Off-shift Work (Line Item 178)" is hereby inserted into the Specification, as follows:

Article 5.35. Allowance for Premium for Off-shift Work (Line Item 178).

In the event a Collective Bargaining Agreement (CBA) for a particular trade requires that a premium (not time and a half or double time) be paid for off shift or night work, the City will reimburse the Contractor for the exact premium via Allowance Line Item 178, provided the Contractor provides a certified payroll showing the amount paid and provides a copy of the CBA that shows that a premium is required to be paid for the off-shift or night work.
