Question 1:	Exhibit 5 & 6 list City facilities and O'Hare fire extinguisher locations. Will this Spec/RFQ also include units/systems at Midway Airport, or is that covered in another specification?
Response:	<i>This contract does not currently include the Midway Terminal and associated buildings. However, pursuant to Section 5.8.5.1, Maintenance Requirements, these listings may be revised at any time during this contract (locations added and/or deleted without formal modification to the contract).</i>
Question 2:	Are all inspection services conducted during normal business hours M-F? if not, what are the exceptions?
Response:	<i>Typically, all inspection services hours are performed during normal working hours Monday through Friday.</i>
Question 3:	Will a list of city site locations and next service due dates be provided to the awardee?
Response:	<i>For Aviation, please reference EXHIBIT 6: O'Hare Fire Extinguisher Locations List. Next service due dates will not be provided at this time as the award date of this contract is currently unknown.</i>
Question 4:	Page 76 - can you please provide the GPM for each fire pump listed that is to be

	serviced?
Response:	Please see Exhibit 7 attached to this Addendum No. 4 as Attachment 3.
Question 5:	Page 76 – are all the fire pumps listed located on O'Hare property, or other site locations?
Response:	<i>All fire pumps listed in Exhibit 7 attached to this Addendum are currently located at O'Hare International Airport.</i>
Question 6:	Page 140, line items 107-109. Should this pricing be provided under the Discount or Markup % column vs Price column?
Response:	<i>Please see revised proposal pages. The Mark Up or Discount percentage should be placed in the column headed "Discount or Mark Up %" and then the resulting extended price after applying that mark up or discount percentage to the figure in the "Estimated Usage" column should be placed in the "Extended Price" column.</i>
Question 7:	Page 140, line item 102, Please clarify the UOM of 5 that is shown. Is this the annual cost for all 13 fire pumps, or something else?
Response:	<i>Please see revised Proposal Pages attached to this addendum as Attachment 2. The price proposed should represent annual cost of inspection for each fire pump listed in the Revised Section 5.8.9 and Exhibit 7 which have been added to this Addendum as Attachment 1 and Attachment 3. CDA currently has 12 pumps, so the estimated quantity is now 60. Pursuant to Section 5.8.5.1, Maintenance Requirements, the City may elect to add or delete fire pumps without formal modification to the contract. The City may also elect to use a different means outside of this contract to accomplish testing.</i>
Question 8:	Page 141 – line item 110, is this for fire extinguisher and CO 2 system repair parts?
Response:	<i>Yes, line 110, as well as line items 107-109 and line item 111, allows for the purchase of all items within the stated catalogs for the service / replacement of fire extinguishers and fire suppression systems.</i>
Question 9:	Please clarify why the Commodity desc for line items 118 and 119 would include "sprinkler fitter/pipefitter" for fire protection equipment, fire extinguisher maintenance?
Response:	<i>Please reference Line Items 118 and 119 - Sprinkler Fitters/Pipe Fitters would be used to repair or maintain the sprinklers or piping of the suppression systems as necessary.</i>
Question 10:	Page 81, Section 5.8.20. If a bidder firm is not an authorized dealer/distributor or reseller of certain manufacturers, but has a business relationship established with a company that is, and can obtain genuine parts/certified personnel as needed, will this be acceptable?
Response:	<i>Refer to Section 5.8.20; the Bidder must supply a letter from the manufacturer noting they are an authorized dealer distributor or reseller.</i>
Question 11:	Would the City consider multiple service providers for the services (i.e. fire extinguishers and/or fire suppression and/or fire pumps) covered under this Specification?
Response:	<i>No. Please refer to Section 1.20.1.1; the bidder must bid all Line Items set forth on the Proposal Pages.</i>
Question 12:	Is it acceptable for a firm to submit a bid for a selection of line items services (i.e. fire extinguishers -or fire suppression -or fire pumps) and not all?
Response:	<i>See response to Question 11</i>
Question 13:	Is it acceptable to use sub-contractors for any of the services covered in the Spec/RFQ?
Response:	<i>Please refer to Section 3.1.3.2, Subcontracts, of the Specification. Also, please refer to Section 1.22.1, Bid Incentive to Encourage MBE/WBE Utilization on No Stated Goals Contracts and Article 6. Special Conditions Regarding Minority Business Enterprise Commitment and Women Business Enterprise</i>

Question 14:	Page 23, Section 3.1.3 What is the process for getting a sub-contractor for any services in this Spec approved by CPO? Does this need to occur before or after the bid opening date?
Response:	<i>See answer to Question 13.</i>
Question 15:	Page 140, line items 103 thru 106. Are these Miller Peerless water units? is Ri Del the sole source for these units, or can bidders be provided with alternative sources to obtain pricing for repair parts?
Response:	<i>Please see revised Proposal Pages. Bid Lines 103-106 have been deleted from the Specification.</i>
Question 16:	Page 77, Section 5.8.11. Are Catalog pricing pages to be provided with the bid, or only noted as a % disc/markup as shown on pages 140 and 141 line items 107 thru 111.
Response:	<p><i>The line items 107 through 111 only require a percentage (%) markup or discount for the approved manufacturer's catalogs listed in Section 5.8.11.</i></p> <p><i>Copies of current manufacturer price lists must be provided when requested for by the CPO (which may be at any time after award - and must be furnished within three business days thereafter) but price lists must be furnished no later than within three (3) days of Contract award, as requested by the various using departments and at any time new price lists are published by the various manufacturers.</i></p>
Question 17:	5.8.9 Annual Fire Pump Testing - On page 76 of the bid documents, there are 13 Fire Pumps listed and their respective locations. Would you be able to provide the GPM's for each of those fire pumps, please?
Response:	<i>Please refer to Exhibit 7 attached to this Addendum as Attachment 3.</i>
Question 18:	Page 140, Line Item 102 – The estimated usage is listed as 5. The number of fire pumps listed on page 76 is 13. Will line 140 be updated with a quantity of 65, instead of 5?
Response:	<i>See answer to Question 7.</i>
Question 19:	Page 139, Line Item 94 – Should the estimated usage be 5, instead of 100. (typo?)
Response:	<i>The system utilizes Halotron Clean Agent. Line item 94 quantity has been revised to 15.</i>
Question 20:	Line 94 – This line states Foam Suppression but then also Halotron clean agent. Which type of system is it as they are priced differently by Cintas?
Response:	<i>The system utilizes Halotron Clean Agent.</i>
Question 21:	Line 102 – This line states Fire Extinguishers, but also Fire Pump. Which system type is it and if they are Fire Pumps, what are the GPMs of each?
Response:	<i>Please see revised section 5.8.9 as well as new Exhibit 7.</i>
Question 22:	Lines 103 to 105 – Looking for further clarification. Are these are for Fire Hoses?
Response:	<i>Lines 103--105 have been deleted in their entirety from this bid solicitation.</i>
Question 23:	Line 106 – Looking for further clarification. Is this for the actual full new hand pump and there are 7008 of them?
Response:	<i>Line 106 has been deleted from this solicitation.</i>
Question 24:	Lines 107 to 111 - Looking for further clarification. There are dollar amounts in there. Are those set limits? Are those catalogue costs and we need to show what are costs are from MSRP? What specifically are you looking for this category? Is this for O-rings, valve stems, or other parts replaced during 6-year maintenance or 12-year hydrostatic testing?
Response:	<i>The Contractor must provide a mark up or discount from the then current list prices in the catalog stated for each line item. The parts could be any part listed within that specified catalog. The mark up or discounts bid by the</i>

	<i>Contractor for each line item are static throughout the contract. The Contractor must provide updated pricelists as they are published by the stated manufacturers.</i>
Question 25:	Line 112 – We are confused by this line item. There are a high quantity of parts for both Extinguishers and Suppression systems. For example, for fire Extinguishers this could be signage. For suppression system parts, this could be a multitude of things. Not sure how they'd like us to price that section out or what exactly these are for.
Response:	<i>The Contractor is to provide a mark up over the Contractor's cost for parts that are not available from or incidental under an existing line item on the contract but required to complete the work. For example, if you provided a part that your supplier invoiced you \$100 for and you had bid a 5% mark up on the proposal page you would be able to charge the City \$105 for that part. Further, as the estimated quantity on that line item on the proposal page is \$75,398, if your mark up percentage is 5% you would put 5% in the "Discount or Mark up" column, and then your extended price would be \$79,167.90 based on $\\$75,398 \times 1.05$.</i>
Question 26:	Line 118 – The RFQ is asking for Sprinkler Fitter Labor time. Do you need the normal rate or the Prevailing Wage rate here?
Response:	<i>The Contractor is to provide their fully loaded rate for providing a sprinkler fitter. Contractor must pay the employee Prevailing Wage.</i>
Question 27:	Line 119 – The RFQ is asking for Sprinkler Fitter Labor time. Do you need the normal rate or the Prevailing Wage rate here?
Response:	<i>The Contractor is to provide their fully loaded rate for providing a pipe fitter. Contractor must pay the employee Prevailing Wage.</i>
Question 28:	Is Prevailing wage that is mentioned in this bid applicable to the Fire Extinguisher Service? If yes: Can you identify which labor classification?
Response:	<i>Prevailing Wage is not applicable to Fire Extinguisher Maintenance; however, sprinkler fitter and pipe fitter are to be paid as Prevailing Wage.</i>

This Solicitation is now an eProcurement Bid. Bids are to be submitted through the City's "iSupplier" system, the City's eProcurement computer system for electronic bidding and providing Contractors with access to contract, ordering and payment information for their City contracts.

1. Obtaining the Bid Documents

In order to receive notice of clarifications and addenda, Bidders must be registered for and log-in to iSupplier, search for the solicitation number, open the solicitation for review, and accept the disclaimer. This will sign Bidders up for notifications.

Bid Document Holders are listed on the Bid & Bond Room Opportunity Take Out List. The Opportunity Take Out List is public information and is posted to the DPS web site at www.cityofchicago.org/TOL. To find Opportunity Take Out lists go to "GetStarted Online" and search by the specification number.

2. Clarifications and Addenda

Preparing Bids: Required Information and scan and upload all forms and required information as attachments to the electronic bid submission. Bidders may not change any of the Bid Documents. Any changes made by a Bidder to the Bid Documents may result in rejection of the Bid and will not be binding upon the City.

Bidders must submit their pricing as an attachment in the iSupplier system to be reviewed for consideration.

ATTACHMENT 1

Revised 5.8.9, Annual Fire Pump Testing (Bid Line Items 102 and 123)

The Chicago Department of Aviation under the jurisdiction of the City of Chicago Department of Buildings and Chicago Fire Department must test all fire pumps on an annual basis under Sections 9 (15-16-260), 4(13-76-120), 9(15-16-1150) and 9(15-16-1160) of the Chicago Fire Prevention Code requiring an annual test of fire pumps.

Additionally, under NFPA 25 Section 8.3.3.1, Inspection, Testing and Maintenance of Water Based Fire Protection Systems, flow tests must be performed annually for each fire pump.

The Contractor shall provide all necessary tools including but not limited to gauges, hoses, and ladders needed and required to perform the annual testing under the City of Chicago ordinances as well as NFPA guidelines as noted above. The Contractor shall notify and coordinate with the Chicago Fire Department and Department Commissioner or designee. The testing shall be performed as directed by the Commissioner and typically takes place each year between May and September.

Within two (2) weeks of the completion of the testing for each Fire Pump, a "Fire Pump Test Report" shall be provided to the Commissioner. At a minimum, the report shall include results of the test for each pump including flow rates, voltage, amperage, Revolutions per minute (RPM), suction, discharge, nozzle pressure, total Gallons per minute (GPM) and general status of each pump.

Under bid line item 102 the Contractor will be compensated on a per test basis for the actual cost of performing the fire pump test not including the fees that must be paid to the City (Chicago Fee or Brycer Fee). The unit price bid under line item 102 is for all sizes of fire pumps the City may request be tested. The Contractor will be compensated at the rate proposed on the proposal page (or latest revision thereof) for each fire pump test and report completed and accepted by the Commissioner

Under Allowance line item 123, the Contractor may invoice the City their direct cost for the then current Chicago Fee and Brycer Fee they have paid to the City on behalf of CDA. To invoice for this reimbursement the Contractor must include a paid receipt (or similar documentation) that substantiates the fees for the pump(s) have been paid. The Contractor may not mark up the fees that are charged by the City as the Contractor will only be reimbursed at direct cost.

Below is a list of the current fire pumps at O'Hare which is subject to change during the life of the contract. This list is further detailed to show the Gallons Per minute in Exhibit 7.
