



Pursuant to Section 2-92-644 of the Municipal Purchasing Act, I am authorizing an Operational Emergency procurement for Removal and Disposal of Hazardous Waste due to public health and safety issues. Based upon information received from members of your staff, I have determined that this procurement is necessary to meet a bona fide operational emergency.

You are hereby authorized to procure the Removal and Disposal of Hazardous Waste services from Heritage Environmental Services, LLC for \$23,407.29 as requested in your letter dated October 24, 2006. Any amount in excess of the \$23,407.29 approved here will be subject to additional authorization and will be limited so as not to exceed the \$250,000.00 limit established by statute.

RE: Emergency Contract Request – Heritage Environmental Services, LLC

DATE: October 24, 2006

As stated in previous e-mails, we had to dispatch Heritage Environmental on numerous emergencies throughout the city to remove and dispose of hazardous waste materials due to public health and safety issues. Below is a recap of the emergencies responded to by Heritage. Also, attached please find the invoices for each emergency response and the requisition for immediate payment.

1. At the request of the Chicago Police Department, DOE had to dispatch Heritage to remove and dispose of chemicals from a home located at 6301 N. Louise that caught on fire. The cost for this emergency was \$2,045.45.
2. Dye was spilled by Water Management at a residence home located at 1716 W. Altgeld and required immediate cleaning. The cost for this clean-up was \$892.40.
3. At the request of Water Management, we dispatched Heritage after a water main break at 3200 S. Wood. The water line got contaminated and required cleaning to avoid a public health issue. The cost for this emergency was \$5,541.80.
4. Heritage was dispatched to secure and contain leaking material at a plating facility located at 3114 S. Kolin. The cost for this emergency was \$700.60.
5. Heritage was dispatched to 11200-32 S. Edbrooke to remove hazardous materials stored in the building. The building is owned by Planning & Development and the Fire Department wanted these material removed immediately. The cost for this emergency was

- \$5,863.21.
6. Poisonous materials were dumped in the alley at 7642 S. Wallace and had to be removed immediately. Heritage was dispatched to remove and dispose of the hazardous materials. The cost for this emergency was \$1,874.31.
 7. There was a chemical spill from a Streets & Sanitation truck at 500 W. 43rd St. and the Fire Department requested DOE to remove and dispose the hazardous materials. Heritage was dispatched to clean-up the area. The cost of this emergency was \$2,925.44.
 8. At the request of Water Management, Heritage was dispatched to the Jardine Water Plant (1000 E. Ohio) to remove containers of chemicals in a non-functioning refrigerator. The cost for this emergency was \$916.12.
 9. Heritage was dispatched for a hazmat clean-up at Grand Ave. and Rutherford. A large tote of oil came off the back of a truck spilling onto the street, sidewalk and catch basin. The cost for this emergency was \$2,710.96.
