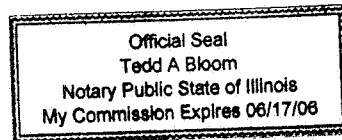



The floor slab columns and beams have deteriorated to the extent that supplemental wood shoring has been installed in the basement. The advent of new fire trucks and their additional weight has prompted the Fire Department to request a permanent solution. This project is a total fix and consists of install new steel columns and beams on new footings.
- 2. Please explain why this project could not be bid using the City's traditional bid process, and the need to use JOC procurement system:**  
The floor slab and basement columns and beams have deteriorated so much that it is becoming a life and safety issue. The JOC procurement method affords us the flexibility and contractor control to complete this project in the most economical and expeditious manner.
