1. Please describe the major feature of this project.

This project is installing a new residential street lighting system in the 3th Ward on 44<sup>th</sup> St. from Vincennes to St. Lawrence, 48<sup>th</sup> St. from M.L. King Dr. to St. Lawrence, 48<sup>th</sup> Pl. from M.L.K. Dr. to Vincennes and 49<sup>th</sup> St. from M.L.K. Dr. to Forestville. It's part of Aldermanic Menu Program. B.O.E. will supply davit poles and luminaires which City Lights will install. City Lights will supply helix foundations, piggyback fixtures, handholes, directional bore conduit, and supply all material and equipment needed. .

2. Please explain why this project could not be bid using the city's traditional process and the need to use the JOC procurement system.

The Bureau of Electricity had planned to do this project with City Forces, but due to our work load, we can't do it in a timely manner. The Bureau of Electricity can't use the traditional bid process because of the time frame involved. The Bureau of Electricity established JOC to help us manage these situations when they occur.
