1. Please describe the major features of this project.

The scope of work to be performed under this sub-order shall consist of removing and replacing Curb and Gutter, PCC sidewalk, and ADA compliant Sidewalk Ramps at the intersection of Halsted Street and Waveland Avenue where Bureau of Electricity has completed the installation of the new traffic signal. Additionally, the work will include resurfacing and new pavement markings.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

This project was designed to be built by Bureau of Electricity. However, due to lack of concrete finishers at BOE, the concrete portion of the work could not be completed by BOE. The limited scope of work precludes this project from traditional bid process.

3. If the project is a one trade project, please provide additional explanation of why it would be in the city's best interest to do the project under JOC:

This project is not a one trade project.

4. If it is anticipated that over 25% of the project will consist of Non-prepriced items, please provide an explanation on why JOC should be used.

This project will be priced fully by the JOC contractor.

5. If some elements of the proposed JOC project scope of work are covered by city term agreements, explain why they are included in this JOC project instead of being procured through the term agreements.

This project must be completed in advance of the opening of a new community center. Therefore, it would be impossible to coordinate this project with the RCMA contractors in advance of the grand opening due to the current workload of the RCMA contractors.
