1. The Sub Order amount differs from the MOA estimate for the following reasons:

The final construction cost proposal is only about 40% of the MOA estimated price due to uncertainty of the condition of the existing downspout which is concealed inside the wall. Once the work begins it is anticipated that the repairs will be less extensive than originally assumed.


