Vaulted sidewalks on Dearborn Street between Jackson Blvd and Van Buren Street require structural repairs in order to install pedestrian ramps for ADA compliance. The repairs require the demolition and reconstruction of the structural roof of the vaulted sidewalks. This work can not be performed by City Forces and is not covered by an existing term agreement.
