# PROGRAMS & INITIATIVES

## Capital Plan

The **Chicago Works Five-year Capital Plan** is a multi-billion dollar initiative to allocate spending to improve the quality of life for all Chicago residents by investing in infrastructure and City in City facilities in all 77 communities. The Plan is estimated to put thousands of Chicagoans back to work and will address a decades-long backlog of infrastructure needs. It also aims to reduce operational costs and concerns about aging infrastructure. Contracts with this designation will place high priority on working with minority- & women-owned as well as locally-owned businesses.

## Small-Business Initiative

Exclusive opportunities for small business enterprises and limited to construction projects that are under \$3M in total cost.

**Referred to in the Bid Opportunities as SBI.**

## Mid-size Business Initiative

Open to both small **and** mid-sized business enterprises and limited to construction projects that are between \$3M and \$10M in total cost. This initiative expands on the SBI program and encourages growth and graduated participation.

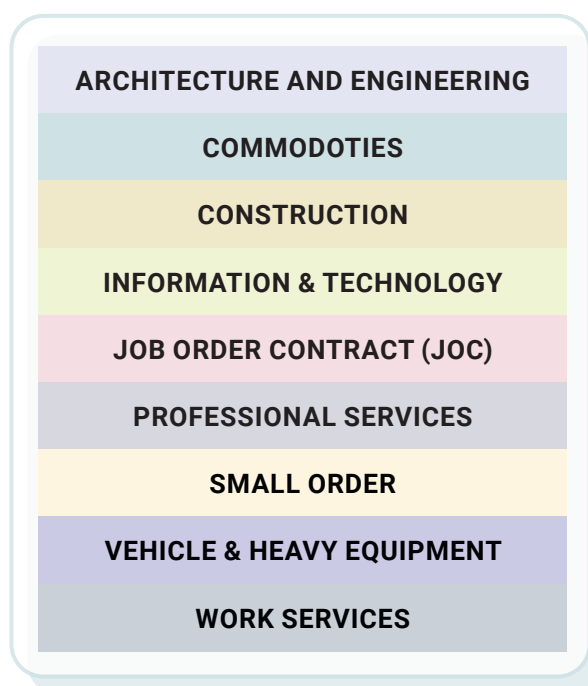

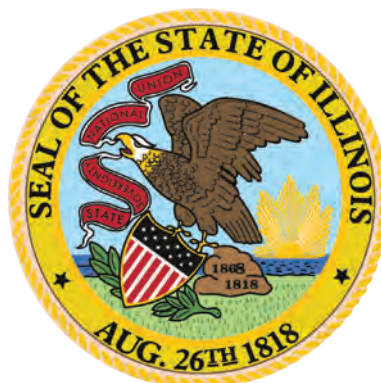

# GOVERNMENT PROCUREMENT COMPLIANCE FORUM

Collectively, our regional governments procure a wealth of goods and services annually. By making our processes more streamlined, standardized, equitable, and transparent, we are not only creating an environment in which businesses of all sizes can flourish but will be better stewards of taxpayer dollars.

The City of Chicago Department of Procurement Services (DPS) initiated a series of meetings with the City's sister agencies and invited County, State and Federal government as well as the Affirmative Action Advisory Board and non-profit assist agencies representing the vendor community.

These meetings have grown into the Government Procurement Compliance (GPC) Forum, a strategic planning effort, which entails the formation a number of working subcommittees tasked with researching and reviewing best practices and recommending solutions to shared challenges.

## GPC FORUM MISSION

**DRIVE BOLD, CROSS-AGENCY IMPROVEMENTS TO MAKE OUR REGION THE BENCHMARK FOR PROCUREMENT, CERTIFICATION, AND COMPLIANCE PROCESSES THAT ARE STREAMLINED, STANDARDIZED, EQUITABLE AND TRANSPARENT.**

One of the objectives of the GPC for its participating agencies was to roll-out this unified quarterly buying plan across the City, its sister agencies, as well as the County and State, so that vendors can better plan for bidding on government business.

The GPC Forum includes:

- More than **30** participants
- More than **40** government entities & non-profit assist agencies representing local small minority and women-owned businesses.
- **3** working subcommittees:
  - Legal Issues/Payments
  - Transparency, Outreach & Capacity Building for Vendors
  - Certification, Compliance & Good Faith Efforts
- Subcommittees are made up of a mix of government institutions and assist agencies to foster an environment of collaboration and inclusion.
