

#### Capital Plan

The Chicago Works Five-year Capital Plan is a multi-billion dollar initiative to allocate spending to improve the quality of life for all Chicago residents by investing in infrastructure and City in City facilities in all 77 communities. The Plan is estimated to put thousands of Chicagoans back to work and will address a decades-long backlog of infrastructure needs. It also aims to reduce operational costs and concerns about aging infrastructure. Contracts with this designation will place high priority on working with minority- & women-owned as well as locally-owned businesses.

#### Small Business Initiative

Exclusive opportunities for small business enterprises and limited to construction projects that are under \$3M in total cost.

Referred to in the Bid Opportunities as SBI.

Target Market

Exclusive opportunities for city-certified businesses that are minority or women-owned. Vendors wishing to become certified in order to bid on Target Market opportunities may visit the Resource Guide on Certification here:

#### Mid-size Business Initiative

Open to both small **and** mid-sized business enterprises and limited to construction projects that are between \$3M and \$10M in total cost. This initiative expands on the SBI program and encourages growth and graduated participation.

## I'm interested in a bid opportunity mentioned in the buying plan. What do I do now?

Pay attention to the Ad Date column, this will tell you approximately what quarter the solicitation is expected to be publicly advertised.

Once a solicitation is advertised, you can use the project title or specification number to find the Bid Package and view the contract details and begin preparing your bid.

#### Where are bid opportunities advertised?

If it is a City of Chicago opportunity, open solicitations are advertised in the Chicago Tribune and the Bid Package is made available online in **eProcurement** (**Chicago.gov/eProcurement**).


