

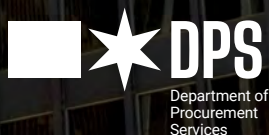

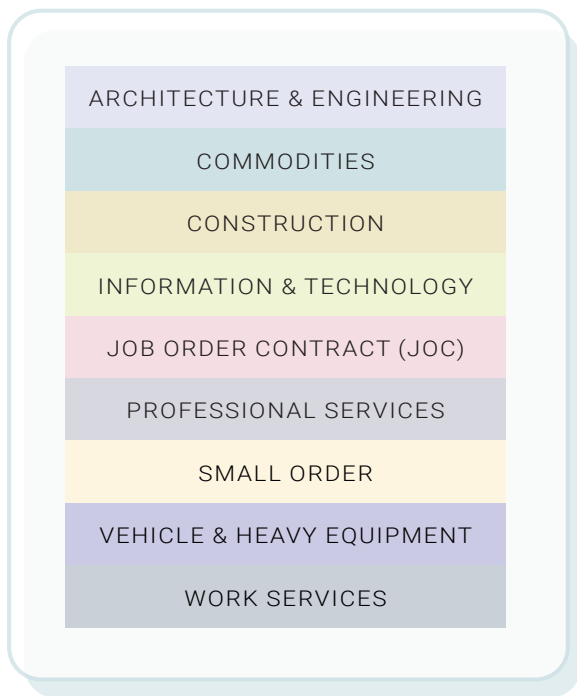

## Capital Plan

The **Chicago Works Five-year Capital Plan** is a multi-billion dollar initiative to allocate spending to improve the quality of life for all Chicago residents by investing in infrastructure and City in City facilities in all 77 communities. The Plan is estimated to put thousands of Chicagoans back to work and will address a decades-long backlog of infrastructure needs. It also aims to reduce operational costs and concerns about aging infrastructure. Contracts with this designation will place high priority on working with minority- & women-owned as well as locally-owned businesses.

## Small Business Initiative

Exclusive opportunities for small business enterprises and limited to construction projects that are under \$3M in total cost.

**Referred to in Bid Opportunities as SBI.**

## Mid-size Business Initiative

Open to both small **and** mid-sized business enterprises and limited to construction projects that are between \$3M and \$10M in total cost. This initiative expands on the SBI program and encourages growth and graduated participation.

**Referred to in the Bid Opportunities as MBI.**
