This workshop will provide detailed information on how to be a Chicago certified firm and the documents needed when submitting an application. Also, learn how to avoid the most common mistakes in the certification process.

Do you have questions about how to become a successful bidder on City contracting opportunities? Unsure where to begin? Additionally, the Department of Family and Support Services and Chicago Cook Workforce Partnership will feature programs they offer.

eProcurement applies digital technology to the acquisition of goods and services. It will allow DPS to collaborate with City Departments to create solicitations and contracts online, greatly reducing the time it takes to complete procurements.
