The Chicago Police Department would like to thank the Office of Community Oriented Policing Services once again for its generous 2007 COPS Technology grant. During the planning stages of this effort, we have identified the need to request a budget modification as detailed in the attached pages. The largest single change is the addition of Oracle licensing and maintenance costs required to support components of the applications being developed as part of the grant, which are not funded elsewhere. We are also removing the COPLINK component to develop a scalable front-end that will simplify the incident reporting process for our reporting agencies (Web Services Front-End User Interface). Funding is re-allocated to support the purchase of a Core Technology Software License to support the Hot Desk component of the grant.
