(X) PROCUREMENT HISTORY

The City retained Civitium, LLC for consulting services for the "Broadband Master Plan" projects. Under the original contract (specification number 38985), Civitium, LLC provided advisory services related to the development of a comprehensive, long-term master plan for broadband in Chicago.

The Department of Innovation and Technology is petitioning a no-bid contract on behalf of Civitium, LLC in order that they may provide management and technical consulting services for "Fiber Network Specification and Grant Application" for the City. (SEE ATTACHED)

(X) ESTIMATED COST

Civitium, LLC has proposed to conduct the services stated above for a flat fee of \$325,000 over a 75 day period. (SEE ATTACHED)

(X) SCHEDULED REQUIREMENTS

The proposed services are to be completed in a 75 day timeframe. No extension of the duration of the current contract is required.

(X) EXCLUSIVE OR UNIQUE CAPABILITY

Through its extensive prior work with the City over the course of two years, Civitium has developed expert and proprietary knowledge of the City's policies, programs, infrastructure and personnel that is indispensable for the "Fiber Network Specification and Grant Application" project. Were the city to retain another firm for development of a broadband master plan, the new firm would have to develop this background, resulting in an unacceptably longer timeline that would compromise the City's competitiveness for stimulus funding.

The project will critically important for Chicago's application for highly competitive funding from the American Recovery and Reinvestment Plan (ARRP). The ARRP requires that projects be "shovel-ready" at the time of application and Civitium's delivery of a fiber network specification is necessary to achieve this state of readiness.



RE: Proposal for Fiber Network Specification and Grant Application Services

Dear Hardik:

Through our background research and outreach to Chicago departments and sister agencies during the Broadband Master Planning (BMP) process, we have discovered that the City has access to a vast infrastructure of fiber optic cabling and other important assets. We have also discovered that this infrastructure is not utilized to its full potential or leveraged adequately for public benefit. With the proper aggregation of these existing assets through the deployment of modern networking technologies, in concert with the construction of new fiber optic cabling to reach under-served neighborhoods within the City of Chicago, we believe that the City would be taking a significant first step in meeting its medium and long term broadband infrastructure goals.

We believe that time of the essence. Section 1102 of the American Recovery and Reinvestment Act of 2009, gives preference to quick start activities:

"In using funds made available in this Act for infrastructure investment, recipients shall give preference to activities that can be started and completed expeditiously, including a goal of using at least 50 percent of the funds for activities that can be initiated not later than 120 days after the date of the enactment of this Act."

In a recent meeting hosted by the NTIA, the agency responsible for administering the broadband grant funds relevant for Chicago, it was stated that funds would be administered in three rounds, with the first round opening between April and June, 2009.

Given the short timeline for grant submission to NTIA, and the fact that Chicago's investment in this area may be largely tied to succeeding with such a grant, we feel it is critical for DoIT to proceed with a rapid process to get this project grant ready Over the next 60-75 days.

We have determined that the first phase recommendation of the BMP includes several unique project functions, including:

- 1. Technical Specifications for a Core Fiber Optic Network
- 2. Technical Specifications for Point-of-Presence Facilities

- 3. Civil Engineering for Fiber Optic Cabling and Conduit
- 4. Facilities Engineering for Point-of-Presence Locations
- 5. Fiber Optic Cabling and Conduit Installation
- 6. Point-of-Presence Construction
- 7. Network Implementation
- 8. Network Testing & Verification

It is clear that the first phase of the plan will require a combination of domain expertise from a variety of City agencies and vendor organizations; however, we believe that a grant proposal for stimulus funding through the NTIA will require only the completion of Items #1, and #2; Technical Specifications for a Core Fiber Optic Network and Point-of-Presence Facilities.

We recognize that City agencies such as the Public Building Commission (PBC) and the Office of Underground Coordination must play a significant project role in Items #3 through #8, but that a) these activities will require substantial investment by the City and b) these investments may only be justified after it has become clear whether the City will be awarded funds through the NTIA.

SCOPE OF SERVICES

We propose to develop comprehensive financial, operational and technical specifications for the network and facilities to a level that will be viewed by the NTIA as shovel ready. More specifically, we propose to complete Items #1 and #2 above and to prepare content in support of the City's grant submittal to the NTIA. We propose to commence these services immediately and estimate that this work can be completed within 75 days, and that this documentation will provide the PBC with a critical input for their project formulation of items #3 through #6.

Civitium proposes to provide the following professional services associated with Items #1 and #2 above:

- Detailed specifications for a core fiber optic network, which will include the
 aggregation of existing City and sister agency fiber assets and recommendations for
 the construction of new fiber optic lines to create a citywide core transport
 network;
- Detailed specifications for points-of-presence (POP) facilities, which will include specifications for all network-related equipment, cable routing, environmental considerations, equipment racks, physical security, etc. To accomplish this, we will identify up to five (5) candidate facility types, which may include public-owned facilities such as schools, city buildings, fire stations, etc. We will perform a site

survey of one (1) facility for each of the five (5) types of facility identified. We will develop blueprints/drawings illustrating the manner in which each facility type can be made-ready to meet the specifications defined above. We will also work closely with PBC to identify cost assumptions for any of the make-ready improvements identified during these site surveys.;

- Detailed specifications for a Fiber to the Premise (FTTP) network, which will include
 the physical network routing and topology to reach up to 10,000 residences and
 businesses in underserved neighborhood(s) and economic development zones
 within Chicago;
- Identification of fiber optic cabling installation methods such as trenching, micro trenching, in-sewer and aerial. This will include cost sensitivity information as part of the financial analysis referenced below;
- Creation and aggregation of documentation and content to support a comprehensive NTIA grant proposal;
- Development of a 10-year financial and operational plan that estimates all capital and operating expenditures, revenues, cash flows, return on investment metrics, and key business assumptions;
- Development of a detailed business plan that describes the business model for the initiative, roles of all participants, broadband policy positions (e.g. network neutrality, open access), and recommendations on how this model should evolve over time; and
- Coordination with the PBC (and/or designees) for the clarification of design and cost estimates, including participation in cost estimate reconciliation meetings.

Elements related to Items #3 through #8 defined above are outside the scope of what we are proposing. These exclusions include, but are not limited to site identification, site acquisition, fiber route and site surveys, professional engineering, coordination of utilities and rights-of-way, facilities engineering, and physical network configuration and deployment.

DELIVERABLES

The primary deliverables from this engagement will be a financial and operational plan, detailed specifications for the deployment of a core fiber optic network, FTTP pilot and POP facilities, and content to support a compelling NTIA grant submission.

These deliverables will include, but not be limited to; logical and physical network drawings and diagrams, GIS maps, technical build specifications, and financial and operational plans. In addition, Civitium will provide an Executive Summary, which may be used to communicate and

socialize the specifications to the Mayors Office, City Council, or other executive stakeholders as required.

REQUIREMENTS OF THE CITY

- The City will provide a dedicated project manager during this engagement to work with Civitium and coordinate interaction with city department and sister agencies.
- The City will provide office space for up to three resources form Civitium and its subcontractors during the engagement.
- The City will provide legal counsel for any issues requiring legal or regulatory analysis or opinions.

SCHEDULE

Upon timely acceptance of this engagement letter, Civitium is prepared to commence work on the project as early as the week of April 6, 2009. We estimate this work will take place over 75 days, with delivery of the final design in June of 2009.

PROFESSIONAL FEES

Civitium proposes to provide the services outlined above for a total of \$325,000, which is inclusive of all professional fees as well as any expenses incurred by Civitium such as airfare, meals, lodging, parking, and ground transportation. These fees will be paid 1/3 upon commencement of services, 1/3 thirty days following commencement of services, and 1/3 upon the City's acceptance of all project deliverables.
