Our comprehensive approach to systemic change for people with disabilities includes: the delivery of direct independent living services; public education and awareness about disability issues; public policy; and initiatives with the goal of making Chicago the most accessible and inclusive city in the nation.
- Additionally, MOPD provides disability-related expertise to City departments and sister agencies, as well as to private sector companies and non-profit organizations.

Who Does MOPD Serve?

- MOPD works to meet the diverse needs of more than 600,000 individuals with disabilities who live in, work in and visit Chicago.
- The ADA defines "disability" as a) a physical or mental impairment that substantially limits one or more major life activities; b) a record of such impairment; or c) being regarded as having such impairment(s).


