The Children Services Division uses support service providers with particular areas of expertise to supplement its management of programs and provide training and technical assistance (T/TA) to a variety of audiences. Support service subject matter experts (SMEs) will provide consultation and T/TA to grantee and delegate agency professionals. It should be noted that support service subject matter experts will not work directly with the children and families, but rather will provide consultation and T/TA to CEL professionals who directly and indirectly work with children and families.
