Chicago Traffic Tracker: Measuring traffic on Chicago's arterial streets

The Chicago Traffic Tracker estimates traffic congestion on Chicago's arterial streets (non-freeway streets) in real-time by continuously monitoring and analyzing GPS traces received from Chicago Transit Authority (CTA) buses. Congestion estimates are produced every ten minutes to measure the current estimated speed for about 1250 segments covering 300 miles of arterial roads.
