SCOPE OF JONES DAY'S REVIEW

We reviewed the City's response to the botched search of Ms. Young's home by four City departments:

- The Mayor's Office
- The Department of Law (DOL)
- The Civilian Office of Police Accountability (COPA)
- The Chicago Police Department (CPD)

SCOPE OF JONES DAY'S REVIEW

Our team:

- Leadership team included four former Assistant United States Attorneys
- Included more than 40 attorneys
- Devoted more than 9,000 hours of pro bono legal services
- Reviewed more than 250,000 internal city documents
- Interviewed more than 40 current or former City employees

SCOPE OF JONES DAY'S REVIEW

We did not:

- Examine the search or investigate any alleged police misconduct related to the search of Ms. Young's home
- Conduct a review focused on disciplining any City official or employee

CONCLUSIONS

- We found no evidence that the Mayor or any current or former City employee took action with malicious intent to add to Ms. Young's mistreatment or otherwise harm her in connection with the City's response to the botched search of her home.
- We found no purposeful concealment of any information by the Mayor or by any City department.
- We found failures in oversight and accountability by each of the four City departments we reviewed.

FAILURES IN CITY'S RESPONSE TO THE SEARCH OF MS. YOUNG'S HOME

We found that certain City officials or employees:

- Did not adequately consider Ms. Young's dignity and did not prioritize certain cases involving egregious misconduct (e.g. psychological/mental trauma)
- Did not follow procedures, maintained flawed procedures, and/or lacked procedures altogether
- Did not adequately communicate within and across departments
- Did not live up to the City's public service mission
- Lacked ownership, including a sentiment of that's "not my job" or siloed behavior, resulting in a scattered response

KEY QUESTIONS:

- 1. Why did it take so long for the City to provide Ms. Young and CBS2 with the body-worn camera footage from the search?
- 2. Why did the City only produce 14 body-worn camera videos in February 2020 when there were actually 22 videos?
- 3. Why did the City's lawyers try to stop CBS2 from airing the body-worn camera footage? Why did the City seek sanctions against Ms. Young in her federal civil rights lawsuit, and why did the City's lawyers drop the sanctions request?
- 4. Why did the Mayor say she only learned of the search of Anjanette Young's home in December 2020, when she had been advised of the search in November 2019?
- 5. Why did the COPA investigation into the search of Ms. Young's home take so long?

WHY DID IT TAKE SO LONG FOR THE CITY TO PROVIDE MS. YOUNG AND CBS2 THE BODY-WORN CAMERA FOOTAGE FROM THE SEARCH?

WHY DID THE CITY ONLY PRODUCE 14 BODY-WORN CAMERA VIDEOS IN FEBRUARY 2020 WHEN THERE WERE 22 VIDEOS?

- Faulty search run for videos:
 - Key search terms missing
 - Some officers turned BWC off and on, creating more than one video for some officers (22 videos created)
 - DOL produces 14 BWC tapes in February 2020
- In December 2020, Mayor orders public release of all videos; proper search identifies 22 videos
 - CPD Sergeant decides on his own that 2 videos from outside the home are not relevant, so only 20 videos are published
 - Last 2 videos are published after Sergeant's decision discovered

WHY DID THE CITY'S LAWYERS TRY TO STOP CBS2 FROM AIRING THE BODY-WORN CAMERA FOOTAGE? WHY DID THE CITY SEEK SANCTIONS AGAINST MS. YOUNG AND THEN DROP THE SANCTIONS REQUEST?

- Feb. 2020: Court order requires BWC footage to remain confidential
- Dec. 12, 2020: Department of Law learns that CBS2 plans to air the footage, which would violate court order
- **Dec. 14, 2020:** Department of Law files motion to stop CBS2 from airing the footage and to sanction plaintiff
 - Then-Corporation Counsel and then-Managing Deputy approve motion without watching videos of search
 - Mayor not notified in advance
 - Court denies effort to stop CBS2 from airing footage

WHY DID THE CITY'S LAWYERS TRY TO STOP CBS2 FROM AIRING THE BODY-WORN CAMERA FOOTAGE? WHY DID THE CITY SEEK SANCTIONS AGAINST MS. YOUNG AND THEN DROP THE SANCTIONS REQUEST?

- Dec. 16, 2020: Department of Law files notice with court at Mayor's direction that the City is only seeking to sanction Ms. Young's lawyer
- **Dec. 17, 2020:** Mayor sends Department of Law new policy directing it to never take court action against media without her prior written consent
- Dec. 18, 2020: Mayor directs Department of Law to withdraw sanctions motion

WHY DID THE MAYOR SAY SHE ONLY LEARNED OF THE SEARCH OF MS. YOUNG'S HOME IN DECEMBER 2020, WHEN SHE HAD BEEN ADVISED OF THE SEARCH IN NOVEMBER 2019?

- Nov. 11, 2019: Mayor receives email about search of Ms. Young's home, while attending Veterans' Day events
 - Email says the search was "a pretty bad wrongful raid"
 - Email provides a summary of the search as described by CBS2. The summary states that Ms. Young was handcuffed and naked for 40 minutes while officers searched her home
 - Mayor responds explaining she has "a lot of questions about this one"
 - Mayor convenes call with senior staff 10-15 minutes later; call and follow-up primarily focus on search warrant working group activities

WHY DID THE MAYOR SAY SHE ONLY LEARNED OF THE SEARCH OF MS. YOUNG'S HOME IN DECEMBER 2020, WHEN SHE HAD BEEN ADVISED OF THE SEARCH IN NOVEMBER 2019?

- **Dec. 15, 2020:** Mayor issues statement saying this was the first time she learned about the botched search of Ms. Young's home
 - Mayor did not remember that she was notified on November 11, 2019
 - Mayor and staff did not search emails to confirm validity of statement
- **Dec. 17, 2020:** Mayor issues second statement indicating she was previously made aware of search in November 2019

WHY DID THE COPA INVESTIGATION INTO THE SEARCH OF MS. YOUNG'S HOME TAKE SO LONG?

- COPA investigation lasted from November 2019 to April 2021 (17 months)
- COPA's long-standing practice was to wait for a sworn statement from a complainant if case in litigation
 - Ms. Young did not provide a sworn statement directly to COPA, like other complainants in active litigation against City
 - COPA did not seek an affidavit override until Dec. 2020
- COPA prioritized other cases
- COVID-19 pandemic impacted COPA's operations
 - Limited ability to conduct in-person interviews and the CPD unions generally would not agree to remote interviews

FAILED TO ADEQUATELY CONSIDER MS. YOUNG'S DIGNITY: RECOMMENDATIONS

- Incumbent upon all departments to recognize that psychological and emotional injury can be traumatic, not just physical injury
- Hire Risk Manager with full access to functioning tracking system to review cases and implement broad-based change
- Identify factors COPA investigators should use to prioritize cases and review periodically
- Build in flexibility for COPA to kick start high-priority cases with additional investigators
- FOIA weekly meetings should include senior-level engagement to appropriately flag risks

DID NOT FOLLOW PROCEDURES, MAINTAINED FLAWED PROCEDURES, AND/OR LACKED PROCEDURES ALTOGETHER: RECOMMENDATIONS

- COPA should implement affidavit override early in investigative process when there is no complainant statement but substantial objective evidence
- Complete CPD General Counsel's draft SOP, and provide associated training to FOIA personnel
- Log body-worn camera footage in uniform manner across all police districts
- Develop specific, periodic trainings on obtaining documents / information from CPD for all Department of Law case teams
- Identify at least one key stakeholder to consistently attend, participate, and flag issues in cross-Department FOIA meetings, and include training for appropriate escalation of issues

DID NOT ADEQUATELY COMMUNICATE WITHIN AND ACROSS DEPARTMENTS: RECOMMENDATIONS


- Formally adopt key values and best practices in writing (mission statements, policies, guidelines), emphasizing that the humanity and dignity of Chicago's residents is a top priority
- Document chain of command or reporting structure for sensitive issues (to include reporting to Mayor's Office and other departments)
- Formalize communication between Department of Law, Mayor's Office, CPD and COPA when civil lawsuits are filed
- Create a citywide FOIA database of requests and responses to track FOIA requests to various departments
- Develop and implement training for CPD's Office of Legal Affairs paralegals to ensure they understand the process to search for, obtain, and send bodyworn camera footage to Department of Law


DID NOT LIVE UP TO THE CITY'S PUBLIC SERVICE MISSION: RECOMMENDATIONS

- Conduct trainings and/or onboarding to reinforce core values and public service priorities
- Develop consistent and thorough training for FOIA officers citywide that emphasizes core value of transparency
- Encourage Department of Law attorneys to take a holistic approach to cases, considering both duty to client and protection of public trust
- Utilize GovQA software to publicly archive responses to FOIA requests


LACKED OWNERSHIP, INCLUDING A SENTIMENT OF THAT'S "NOT MY JOB" OR SILOED BEHAVIOR RESULTING IN A SCATTERED RESPONSE: RECOMMENDATIONS

- Create or update comprehensive policy manuals to clearly delineate employee roles and responsibilities
- Ensure adequate attorney oversight of FOIA responses
- CPD should provide uniform training among its districts on standardized data entry for logging body-worn camera footage
- Formally adopt process around viewing and escalating high-risk and urgent videos

INITIAL NEWS STORY ON MS. YOUNG / OBTAINING BWC FOOTAGE

11/12/2019:

CPD asks for extension on Ms. Young's FOIA request for BWC |

11/12/2019:

- After the media report, Mayor's Office calls to ask what was on the BWC footage; FCRL ACC realizes no response had been received from OLA
- ACC asks paralegal to follow up on the request for BWC, and asks paralegal to add additional named defendants that Ms. Young added in October amended complaint; three officers named in amended complaint not listed by ACC
- No evidence that paralegal followed up with OLA, and she does not recall whether she did so

NOVEMBER 11, 2019

November 12, 2019

11/11/2019:

CPD denies CBS2's FOIA request for BWC (Ms. Young did not consent)


11/12/2019:

First CBS2 story on Ms. Young published; no BWC footage included in the article

INITIAL NEWS STORY ON MS. YOUNG / OBTAINING BWC FOOTAGE

- Nov. 18, 2019: Given that OLA had not responded to the request, ACC also asks one of the CPD investigators detailed to FCRL to pull the BWC videos related to the search at Ms. Young's home
 - ACC provides investigator with the RD number and search warrant data, and investigator pulls the BWC footage
 - At the time, preference for pulling BWC footage through OLA rather than the CPD investigators, but it was not unusual for ACCs to ask a CPD investigator to pull footage if there was a quick turnaround / OLA slow to respond
 - Now, ACCs must obtain approval from a FCRL deputy to obtain BWC footage through the CPD investigators

MOTION TO DISMISS / PRODUCTION OF BWC FOOTAGE



AIRING OF BWC FOOTAGE & MOTION FOR TRO / SANCTIONS

12/14/2020:

- After confirming that City did not produce the video in response to a FOIA request, FCRL attorneys draft and file an emergency motion for a TRO to stop CBS2 from airing the footage in violation of the court's protective order, and for sanctions against "Plaintiff"
- An ACC primarily drafts the motion, with approval from FCRL deputies, Managing Deputy, and Corporation Counsel

December 12, 2020

Dec. 13, 2020

December 14, 2020

12/12/2020:

FCRL attorneys learn that CBS2 obtained the BWC footage from the search at Ms. Young's home

12/14/2020:

- FCRL attorneys reach out to Ms. Young's counsel and CBS2's counsel
- Ms. Young's counsel does not respond; CBS2 responds, sending case law in support of its position
- Court denies the TRO on the same day
- General consensus among FCRL attorneys that motion was properly filed, and they wouldn't do anything differently

RESPONSE TO MOTION FOR SANCTIONS

12/16/2020:

City files a supplement to motion for sanctions, clarifying that it was only pursuing sanctions against Ms. Young's attorney, not Ms. Young herself, and requesting that the Court provide leave to release the BWC videos in their entirety, noting that only "selected portions of the video have been released" I

12/17/2020:

Mayor addresses DOL and instructs Corporation Counsel to send email to DOL with new policy regarding court action against the media

December 15, 2020

December 16, 2020

December 17, 2020

12/15/2020:

FCRL team communicates throughout the day regarding proposed statements and fallout from the motion

12/16/2020:

Ms. Young files suit under FOIA in Cook County against CPD; requests that CPD release all Ms. Young's records under FOIA, and requests a ruling that CPD violated FOIA by failing to do so

AFTERMATH OF MOTION FOR SANCTIONS

- Dec. 17, 2020: CPD releases 20 BWC videos from the search at Ms. Young's home on its website
- Dec. 18, 2020: CBS2 discovers that CPD posted more videos than were produced in the litigation
 - City later determines that Department of Law had only produced 14 of 22 total videos in February 2020
 - Although 14 officers were named in the litigation, some of the officers turned their cameras on and off (creating multiple videos per officer)
 - Consensus among FCRL attorneys that Ms. Young voluntarily dismissed her suit before discovery commenced, and the team would have found the discrepancy and produced the additional videos had discovery continued

AFTERMATH OF MOTION FOR SANCTIONS

12/18/2020:

- City withdraws its motion for sanctions –
 language provided by Mayor, with instructions
 that it be filed without edits
- Court grants the City's motion to withdraw its motion for sanctions but notes that it had "its own concern about noncompliance with, and enforcement of, its orders"

1/29/2021:

Court declines to impose sanctions, noting one reason as the "good faith basis for Mr. Saulter's belief that the City's failure to disclose those materials in response to Ms. Young's state law FOIA request was unlawful"

December 2020

January 2021

12/20/2020:

Corporation Counsel resigns at Mayor's request

1/15/2021:

City files a letter from the Mayor asking the Court not to sanction Ms.
Young's attorney



NOVEMBER 1-8, 2019: CBS2 CONTACTS MAYOR'S OFFICE COMMUNICATIONS STAFF RE: SEARCH AT MS. YOUNG'S HOME

- Nov. 1 & 4, 2019: Initial Contact with CBS2
 - Following up on CBS2's Nov. 1 outreach, the Mayor's then-Deputy Press Secretary has a call with CBS2 on Nov. 4 regarding their 8/21/2019 FOIA request for body-worn camera ('BWC") footage from the search at Ms. Young's home
- Nov. 8, 2019: Follow-Up from CBS2 on Request for BWC Footage
 - CBS2 contacts then-Deputy Press Secretary again regarding request for BWC footage
 - Then-Deputy Press Secretary circulates email containing CBS2's description of the search to then-Communications Director, then-Chief Risk Officer, and then-Deputy Mayor of Public Safety, among others

NOVEMBER 1-8, 2019: CBS2 CONTACTS MAYOR'S OFFICE COMMUNICATIONS STAFF RE: SEARCH AT MS. YOUNG'S HOME

11/4/2019

Initial call with CBS2 re Ms. Young story "Police officers handcuffed Young, who was naked, and allegedly left her standing for 40 minutes handcuffed and naked while all-male police officers searched her apartment."

- 11/8/2019 e-mail from then-Dep. Press Secretary

11/8/2019

11/8/2019 Follow up by CBS2 on Ms. Young story Then-Dep. Press Secretary circulates email to Mayor's Office personnel with CBS2's description of search



CBS2 is working on a story for Tuesday about another wrong raid by the Chicago Police Department. Information on the raid is below but I need CPD to check-in on the FOIA request made by the woman involved in this incident. CBS2's FOIA is below as well but I'm more interested in why the woman-involved hasn't received the video she's requested. Below is the incident as described by CBS2.


Incident: On February 21st, 2019, CPD executed a search warrant raid at (Warrant: 19SW5247). The resident of the address, 49-year-old Anjanette Young was in the middle of changing when her house was raided by the police. Police officers handcuffed Young, who was naked, and allegedly left her standing for 40 minutes handcuffed and naked while allmale police officers searched her apartment. After 45 minutes, a female police officer arrived at the scene and uncuffed the woman and then turned off her body camera to let her get clothes on. According to CBS2, the individual they were looking for as part of the warrant, lived across the street (CBS2 found him). CBS2 also said that Officer Michael Donnelly (Supervisor: Sgt. Wolinski) was involved in obtaining this search warrant, and he was also involved in the Peter Mendez wrongful raid.

Both Young and CBS2 have been requesting body camera footage from the incident since August and have yet to hear back from CPD. Anthony/Anjali -- can you look into this?





"Today, I became aware of an incident involving Ms. Anjanette Young from February 2019, before I became Mayor, and I saw a video today for the first time. I had no knowledge of either until today. I had a very emotional reaction to what was depicted on the video as I imagine that many people did.

"In 2019, I directed the City's chief risk officer to review CPD's search warrant policies and practices, and recommend improvements where appropriate. As a result of that work, and in conjunction with the CPD risk manager, a new search warrant policy went into effect in January 2020. Among the various changes, the new policy requires additional CPD supervisory review and sign off before a search warrant can be sought from a judge, and there must be separate verification that the property in question is indeed the correct location in which evidence of criminal activity can be found.

"I have further directed a review of how this matter was handled by various City departments to determine that there was compliance with City procedures.

"Since this matter is the subject of litigation and an open COPA investigation, I will have no further comment."

 - No consultation with attorneys; supervising paralegal position vacant
 - In late 2019, COPA personnel routinely invoked ongoing investigation exemption if there was an open COPA log number
- Ms. Young's FOIA request to CPD was denied the next day based on ongoing investigation FOIA exemption

NOVEMBER 19, 2019: MS. YOUNG'S CASE LEAVES INTAKE UNIT

- Investigation into the search at Ms. Young's residence is assigned to COPA's General Investigations Unit (from Intake Unit)
 - Case leaves intake without a signed affidavit from Ms. Young
 - Transfer indicates decision not to close the case
 - No one pursues affidavit override within 30 days of the date the complaint was made (December 12, 2019). See § 2.4.1 of COPA's Rules and Regulations.
 - Case is assigned to a unit with experience handling Fourth Amendment cases

FIRST WEEK OF JANUARY 2020: REVIEW OF BWC FOOTAGE AND MEETING WITH SUPERVISOR

- Investigator reviews BWC footage
 - Investigator Googles Ms. Young's name and notices media coverage of the incident about two months earlier
- Investigator meets with his supervisor to discuss next steps for the investigation into the search of Ms. Young's residence
- The case is not immediately prioritized over other cases in Investigator's case load

JANUARY 6, 2020: CBS2'S THIRD FOIA REQUEST

CBS2 sends third FOIA request to CPD

- CBS2 requests any and all BWC footage from officers' body-worn cameras during the search
- CBS2 attaches written permission from Ms. Young to produce BWC footage to CBS2

JANUARY 10, 2020: ATTORNEY GENERAL ISSUES DETERMINATION REGARDING AUGUST 21, 2019 CBS2 FOIA REQUEST

- CBS2 appealed the denial of its August 21, 2019 request to the Office of the Illinois Attorney General's Public Access Bureau
 - On January 10, 2020, the Office of the Illinois Attorney General issued its determination, affirming CPD's decision to withhold the footage on the ground that the request was not accompanied by written consent from Ms. Young
 - However, the decision further noted that if the request were later submitted with Ms. Young's written consent, "the question in any subsequent Request for Review or FOIA lawsuit will be whether CPD proves by clear and convincing evidence that the disclosure of the recordings would interfere with pending or actually and reasonably contemplated law enforcement proceedings or active administrative enforcement proceedings"

JANUARY 14, 2020: CLARIFYING STATUS OF COPA'S INVESTIGATION FOR CPD

- CPD Associate Staff Attorney emails COPA Paralegal II regarding Ms. Young's January FOIA request to CPD
 - Asks COPA Paralegal II if COPA's investigation is still pending
 - Asks COPA General Counsel to weigh in on basis for withholding video

JANUARY 15, 2020: CLARIFYING STATUS OF COPA'S INVESTIGATION FOR CPD

- COPA Paralegal II responds that log number is still pending and, for that reason, COPA would not release body camera footage; COPA General Counsel bcc'ed
 - FOIA request is not forwarded to then-Chief Administrator and Public Information
 Officer as required by internal FOIA policy (1.3.5 External Requests for Information
 / FOIA, Appendix 1.3.5A(D)), which applies to all FOIA request from media outlets
- General Counsel of COPA did not recall discussing Ms. Young-related FOIA request with CPD or COPA paralegal; viewed handling request as the paralegal's job
- No response sent to CBS2 regarding its third FOIA request until after video publicly released in December 2020

JANUARY 15, 2020: CLARIFYING STATUS OF COPA'S INVESTIGATION FOR CPD

- General Counsel of COPA felt it was inappropriate for COPA to tell CPD what to do with a FOIA request addressed to CPD
- However, CPD attorneys believed that they should not release materials that COPA indicated would interfere with an ongoing COPA investigation
- CPD therefore deferred to COPA regarding whether to invoke the ongoing investigation FOIA exemption

FEBRUARY-MID-MARCH 2020: COPA ATTEMPTS TO OBTAIN SWORN STATEMENT

- Investigator continues to reach out to Ms. Young's attorney to request Ms.
 Young's cooperation
 - Good-faith effort to obtain complainant's sworn testimony is required by COPA policy
 - Per COPA log, three efforts in late 2019/early 2020 to contact Ms. Young's attorney to obtain her sworn statement: November 2019 (via email and a voicemail), February 2020 (Investigator's Supervisor left a voicemail), and March 2020 (Investigator's Supervisor left another voicemail)
- In early 2020, common COPA practice when a case is in litigation is to wait for a sworn statement in litigation context (e.g., deposition) if the complainant did not voluntarily provide a sworn statement
 - At that time, investigators were rarely directed by their supervisors to request an affidavit override and did not request one unless directed by their supervisors

FEBRUARY-MID-MARCH 2020: COPA MONITORS LITIGATION STATUS; NO ACTION ON ANJANETTE YOUNG INVESTIGATION

- Investigator monitors status of Ms. Young's federal lawsuit for purposes of obtaining litigation-related sworn statement
- March 10, 2020: Ms. Young's federal lawsuit is voluntarily dismissed without prejudice
 - Dkt. 37: "The Court construes Plaintiff's 'Motion to Dismiss Count 1 pursuant to FRCP 41 and Transfer Jurisdiction over the Remaining State Court Counts to the Appropriate State Court' 36 as a voluntary dismissal of her claims without prejudice pursuant to Rule 41(a)(1)(A)(i). So construed, the motion is granted All claims in this case are dismissed without prejudice."

MID-MARCH-APRIL 2020: NO ACTION ON ANJANETTE YOUNG INVESTIGATION

- Investigator on the Ms. Young case promoted to Major Case Specialist in March 2020
- COVID-19 pandemic slows down COPA operations and affects prioritization
 - COPA investigators are unable to conduct in-person interviews due to pandemic, and police unions generally would not agree to remote/telephonic interviews of officers
- COPA prioritizes cases other than Ms. Young's matter
 - Agency Priorities: Officer-involved shootings, cases nearing statute of limitations, legacy IPRA cases
 - Investigator on the Ms. Young case is directed to prioritize other cases and investigations, including (1) Watts investigations, (2) cases that can be finalized without additional interviews, and (3) case on COPA's "Top 15" priority list (juvenile beaten by officer at Red Line stop)
 - Young matter not on the "Top 15" priority list

MAY 2020: SIX MONTHS SINCE INITIATION OF INVESTIGATION

- Pursuant to Municipal Code and Consent Decree, COPA sends standard monthly notice to the Mayor's Office listing all case numbers—but not complainant names—that recently crossed 180-day threshold
 - Spreadsheet notice includes Log Number, Complaint / Notification Date, Category Code, Category Code Description, and Current Status, but does not identify complainant by name
 - List is not cumulative of all cases pending more than 180 days; only cases that recently surpassed 180 days
- May 10, 2020: 180 days have passed since the investigation was initiated, triggering notice requirement
- Ms. Young's case was not included on spreadsheet covering cases that hit the 180 day mark in May 2020, which was sent from COPA to then-Deputy Mayor of Public Safety

MAY-NOVEMBER 2020: NO ACTION ON ANJANETTE YOUNG INVESTIGATION

Only activity on Ms. Young's matter is intermittent checks of state court docket to see if Ms. Young's case was re-filed. No affidavit override requested.

Efforts not reflected on log, but Investigator recalls checking docket

7/2020:

COPA employees begin returning to office (3 days per 2 weeks) and are able to resume some inperson officer interviews 7/2020:

Investigator continues primary focus on finalizing reports in Watts matter and closing cases that can be closed expeditiously

COPA's Response to 2020 Civil Unrest:

- Approx. 500 complaints received in 6 days of protests (roughly equivalent to usual monthly case volume); protest cases prioritized
- Investigator's Supervisor is assigned to lead team created solely to work on protest cases (requiring nearly all of his attention)
 - Investigator on Ms. Young case is not assigned to team responsible for handling protest cases; maintains focus on Watts-related report

8/29/2020:

Investigator is assigned first officer-involved shooting (as Major Case Specialist, expectation is that Investigator will focus primarily—if not exclusively—on shooting for 4–6 weeks)

NOVEMBER 19, 2020: CBS2'S FOURTH FOIA REQUEST

- CBS2 sends fourth and final FOIA request to COPA
 - CBS2 requests any and all BWC footage connected to COPA's investigation of search on Ms. Young's residence
 - CBS2 attaches written permission from Ms. Young that was provided with previous FOIA request to CPD

NOVEMBER 19, 2020: CBS2'S FOURTH FOIA REQUEST

- COPA Paralegal assigned to respond to FOIA request does not:
 - (1) Forward the FOIA request to the Chief Administrator and the Public Information Officer; or
 - (2) Have the response to the FOIA request reviewed by the General Counsel or his designee prior to release
- Both steps are required by internal FOIA policy (1.3.5 External Requests for Information / FOIA, Appendix 1.3.5A(D))

NOVEMBER 25, 2020: CBS2'S FOURTH FOIA REQUEST

 COPA denies CBS2's FOIA request with a more specific explanation of claimed harm to ongoing investigation (upcoming officer interviews), per change in practice instituted in 2020

"Please be advised that this investigation is pending and we are unable to produce the responsive footage to your request at this time. Specifically, COPA is still in the process of serving allegations and conducting all necessary officer interviews. Therefore, any officer Body Worn Camera (BWC) footage falls under the pending investigations privilege at this time, as premature release of this footage would interfere with the integrity of our investigation."

In response to your request, COPA has identified the investigation described above as log no. 2019-0004600. Please be advised that this investigation is preduing and we are unable to produce the responsive flootage to your request at this time. Specifically, COPA is still in the process of serving allegations and conducting all necessary officer interviews. Therefore, any officer Body Worn Camera (BWC) footage falls under the pending investigations privilege at this time, as premature release of this footage would interfere with the integrity of our investigation.

This exemption from production exists under 5 ILCS 140.7(1)(d)(i) and (ii), which permits the withholding of documents created in the course of an administrative enforcement proceeding to the extent that ductionue would materie with "pending or actually and reasonably contemplated law enforcement proceedings conducted by any law enforcement or correctional agency," or "active administrative enforcement proceedings."

- CPD Associate Staff Attorney emails COPA General Counsel and COPA
 Paralegal II (copying COPA Assistant General Counsel and COPA
 Administrative Assistant II) about release of body-worn camera recordings in response to January 2020 FOIA request
 - At this point, BWC footage had been publicly aired after release to media by Ms.
 Young's attorney
 - CPD Associate Staff Attorney seeks to confirm that in light of some video now being publicly released, release of further video would not interfere with ongoing COPA investigation
- The same day, COPA Assistant General Counsel confirms that the further release will not interfere with COPA's investigation

DECEMBER 18, 2020: RENEWED MEDIA INTEREST PROMPTS COPA ACTION

12/18/2020:

Then-Chief of Investigative Operations leaves voicemail for Ms. Young's attorney seeking Ms. Young's cooperation with COPA investigation

12/18/2020:

COPA Investigator's Supervisor speaks with Ms. Young's attorney, who initially agrees to provide an affidavit, but states Ms. Young will not provide an interview

12/18/2020:

At Ms. Young's request, Investigator's Supervisor sends follow-up email connecting her attorney with Chief of Investigative Operations and newlyassigned lead investigator In the end, COPA never received a sworn statement or affidavit from Ms. Young

DECEMBER 18, 2020

12/18/2020:

Then-Chief of Investigative Operations meets with investigators and members of legal department to discuss investigative strategy and assembly of ten-person squad to investigate Ms. Young matter

12/18/2020:

Affidavit override request is submitted; approved same day "Due to the extensive amount of BWC footage in this case, the facts concerning the execution of the warrant were not in material dispute."

DECEMBER 18, 2020: RENEWED MEDIA INTEREST PROMPTS COPA ACTION

- COPA assembles a team of approximately 10 investigators to investigate search of Ms. Young's residence
 - Different members specialize in certain aspects of investigation
 - New lead investigator assigned to case who can devote nearly full-time attention to lead investigation; original investigator remains involved
- Team begins to investigate activities leading up to warrant and during warrant execution

DECEMBER 22, 2020: CITY COUNCIL SPECIAL JOINT COMMITTEE MEETING ON ANJANETTE YOUNG

- COPA's then-Chief Administrator and Chief of Investigative Operations provide opening statement and answer questions from Aldermen
 - Then-Chief Administrator reiterates "early 2021" timing estimate provided at Police Board meeting, but does not commit to a particular month when asked
 - Then-Chief Administrator admits case was not moving forward during pandemic, due to other case priorities

"Alderman, I do want to add at this moment that this case you know was moving and I should have done a better job during COVID and during the pandemic to ensure that as we adjusted to the COVID environment or as we adjusted to responding to the protests—I should have made sure this case stayed on the radar."



- November 10, 2021: COPA publicly releases Summary Report of Investigation
 - Includes allegations made against thirteen police officers and two Sergeants; those allegations were sustained against both Sergeants and six of the thirteen police officers

COPA CHANGES PRACTICE CONCERNING ONGOING INVESTIGATIONS FOIA EXEMPTION

- In light of the Ms. Young matter, in 2021, COPA changed its policy regarding FOIA's ongoing investigation exemption
- Today, it will only invoke the exemption in "exceptional" circumstances where there is a meaningful risk that release would compromise the investigation

- Many federal civil rights complainants represented by counsel decline to cooperate with COPA. Once a deposition is taken in a civil case, COPA is able to obtain the statements of the complainant/litigant. Although the City routinely requests that plaintiffs provide statements as a requirement of settlement agreements, plaintiffs historically do not agree
 - To promote transparency and accountability in cases alleging police misconduct, encourage federal civil rights complainants to agree to cooperation provisions in settlement agreements
 - ✓ In Progress—COPA has begun outreach to Plaintiffs' bar to encourage cooperation and build credibility

- In Progress—Implement affidavit override early in investigative process when there is no complainant statement but substantial objective evidence (e.g., body worn camera footage)
 - Attitude of investigators toward affidavit override changed with Consent Decree-compliant training in November 2020 and IG report issued December 17, 2020; affidavit override no longer seen as rare step
 - COPA has drafted new affidavit override policy; currently under review by Independent Monitoring Team and Office of the Illinois Attorney General
- Follow provision in COPA Rules and Regulations requiring affidavit override decision within 30 days after intake
 - See § 2.4.1 of COPA's Rules and Regulations

- CPD should standardize data entry of BWC footage among police districts and provide training on new procedures
 - Logging currently varies by police district

EFFORTS TO IMPROVE EFFICIENCY OF INVESTIGATIONS

- Add staff specializing in FOIA and transparency issues to more efficiently and accurately ensure appropriate public release of information
 - ✓ In Progress—New Transparency Unit included in 2022 budget
 - COPA will create unit that consolidates its transparency processes (FOIA, Executive Order 2021-1, and the City's Video Release Policy)
 - Will establish four FOIA Officers to increase responsiveness to the public and media
 - Will allow for increased specialization, efficiency, and legal supervision of FOIA responses

EFFORTS TO IMPROVE EFFICIENCY OF INVESTIGATIONS

- If additional investigators are needed, make timely budget request to ensure adequate staffing
- Discuss strategies for identifying any cases that could be efficiently and fully resolved without formal COPA investigation
 - ✓ In Progress—COPA is currently exploring pilot mediation program and non-disciplinary intervention program

- COPA struggles to timely retrieve necessary information (POD cameras on light poles, audio materials, etc.) from the Office of Emergency Management and Communications ("OEMC") because no current ability to access remotely
 - At the end of 2018, COPA identified employees who would spend half time at OEMC pulling relevant records but, due to staffing constraints, program was discontinued
 - Currently, there is no COPA employee assigned to OEMC
- Either create remote access to OEMC materials or identify full-time COPA employee to be assigned to OEMC facility

- COPA investigates under strict confidentiality constraints, and full investigative report only goes to CPD Superintendent
 - Summary Report and Findings are publicly issued (Municipal Code § 2-78-145)
 - Public does not understand full extent of COPA investigations or logic behind certain investigative outcomes
- In Progress—Continue efforts to publicize COPA's work and raise awareness of COPA's process

- Ensure adequate attorney oversight of FOIA responses
 - ✓ In Progress—New Transparency Unit included in 2022 budget, which should increase attorney oversight of FOIA responses

CROSS-DEPARTMENTAL FOIA RECOMMENDATIONS

- Improve coordination among City agencies for FOIA responses
- Create a citywide FOIA database of requests and responses to track FOIA requests to various departments
 - ✓ Complete—GovQA software rolled out to all City departments in November 2020
 - Continue to train and to increase usage in all City departments




PRIORITIZATION OF COPA CASES

- Identify and memorialize factors COPA investigators should use to prioritize cases; review periodically
 - Ensure that individuals subject to gross/egregious mistreatment are prioritized
 - Ensure that psychological harm is considered along with physical harm
 - Be aware of community significance of cases
- Build in flexibility to kick start high-priority cases with additional investigators, and communicate urgency to other City agencies

PRIORITIZATION OF COPA CASES

- Report to Mayor's Office, CPD Superintendent, and Chairman of City Council Committee on Public Safety concerning COPA cases pending for more than 180 days (which is required by both Consent Decree and Municipal Code) lacks critical information needed to provide meaningful updates
- COPA should send report to designated individual within Mayor's Office, CPD Superintendent, and Chairman of City Council Committee on Public Safety of all cases pending more than 180 days, with sufficient information to identify the cases and their import
 - At minimum, report should include case name, nature of case, and time case has been pending
 - Report should be cumulative





As permitted by Section 5 TLCS 140/3(e) of the Act, the time was extended in order to conduct a thorough search for these records. Please be advised that certain information has been redacted due to privacy protection. These redactions are explained below.

Section 7(1)(b) exempts from disclosure "[p]rivate information, unless disclosure is required by another provision of this Act, a State or federal law or a court order." 5 ILCS 140/7(1)(b). The FOIA, in 5 ILCS 140/2(c-5), defines "private information" as follows:

"Private information" means unique identifiers, including a person's social security number, divers's license number, endysee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal teleprone numbers, and personal enail addressees. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person."

Therefore, radio transmission audio concerning private information such as personal addresses and personal phone numbers have been redacted.

In addition, identifying information is exempt pursuant to Section 7(1)(x), 5 ILCS 140/7(1)(x) exempts from disclosure 7(p)ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information. Therefore, audio concerning dates of birth were reducted, as well as images that are clearly an invasion of personal privacy. Such images were properly reducted with sink but pursuant to Section 7(1)(x) of POIA.
