
The attached information is in response to questions posed at our department's hearing on October 23, 2012 to discuss the 2013 budget.

The **Independent Living** Program

Your First Steps to Receiving In-Home Services

The Mayor's Office for People with Disabilities (MOPD) offers many programs to help people with disabilities reach their maximum level of independence. One such program is the Independent Living Program and Orientation.

Step 1: The Basic **Requirement**

Prior to receiving Personal Assistance/ Homemaker Services, it is mandatory that you attend one Independent Living Program Orientation or provide a note from your doctor excusing you from attendance based on your disability.

Independent Living Program Orientations are held at the MOPD Field Office 2102 W. Ogden, Chicago

Orientations are 3 hours long..

A variety of topics are covered on a monthly basis throughout the year. In addition, individuals with disabilities may work one-on-one with MOPD staff to improve their ability to live independently in the community.

Step 2: What You Will Learn

The Orientation will acquaint you with services, programs and skills to enable you to achieve your greatest level of independence.

Here are just some of the resources you'll learn about:

- Coordination with, and connection to, other community services
- Transportation resources, including information about programs such as PACE Paratransit and the Reduced Fare Card for CTA mainline service
- MOPD's employment services and related programs for job seekers with disabilities
- Healthy eating habits and individual dietary concerns.
- Housing resources, energy assistance services and home repair programs
- Household management and personal care service information
- Leisure and recreation program information

Staff is also available to provide answers to your questions and help you with various concerns you may have.



Step 3: You've Completed the Orientation, Now What?

Depending on your individual needs, some or all of these services can be offered through MOPD's Independent Living Program:

Case Management

Case Managers work with clients individually to empower them with their skills, education, and support services needed to achieve a healthy, more independent lifestyle.

Assistive Technology

Residents may obtain home modifications, personal devices or equipment, which help individuals become more independent. Recommendations for home modifications or rehabilitation are made on a case-by-case basis. Training is provided to the recipient and caretakers on the use of the equipment. Cost for assistive technology may not exceed \$1,000.

Activities of Daily Living Skills Training

Through Daily Living Skills Training, clients receive step-by-step instruction on performing housekeeping, meal preparation and personal assistance tasks. MOPD contracts with various social service agencies to coordinate this program.
