The attached information is in response to questions posed at our department's hearing on October 5, 2015 to discuss the proposed 2016 budget.

Alderman Arena asked for update on the CONRAC facilities.

Construction on the O'Hare Intermodal Hub is well underway. This project is delivered by two major contracts. First, the CM@Risk is responsible for delivering the garage, quick turnaround area and guide way for the ATS extension. Currently, CM@Risk is performing site prep and demo, as well as construction of roadways that will connect Mannheim Road to the site of the facility to be used both for construction, namely delivery of the pre-cast in spring 2016, and access to the facility when it is complete. Caisson work will begin later this month.

Second, the design/build vendor responsible for installing the new train control system and guide way equipment on the ATS extension is well underway with design. In addition, the new 36 vehicles for the ATS system are under production.

It is anticipated the project will be complete in the fourth quarter of 2018.
