The following information is provided in response to questions posed at our department's hearing on October 28, 2020 to discuss the proposed 2021 budget.

Alderman Dowell asked for the total number of 9-1-1 police calls and 9-1-1 crisis-related (CIT) calls in 2020, within the context of potential programs for alternative dispatch methods for individuals experiencing a mental health crisis.

To date, the OEMC has received 1,142,457 9-1-1 police calls for service, of which 55,476 were coded by OEMC or CPD as having a crisis-related (CIT) component; these figures are broken out by district in the table below as Attachment A.

The following information is provided in response to questions posed at our department's hearing on October 28, 2020 to discuss the proposed 2021 budget.

Alderman Sawyer asked for the MBE/WBE breakdown related to the OEMC's share of the Urban Areas Security Initiative (UASI) grant.

- PO 33939 for Motorola Solutions Inc. Services for Radio/Encrypted system/radio interoperability: 20% total MBE/WBE (14% Hispanic/ 6% WBE)
- PO 66808 for Motorola Solutions Inc. Services for camera surveillance program: 25% MBE/WBE (25% Hispanic/ 5% WBE)
- PO 30586 Silkscreen for CERT supplies 25% MBE-African American/5% WBE
- PO 30365 Bold Planning for Continuity of Operations Planning (COOP) via Master Consulting Agreement (MCA): 25% MBE-Asian/5% WBE
- PO 43126 Tetra Tech for Mass Care via Master Consulting Agreement (MCA): 20% MBE/10% WBE Per Task Order

USAI funds are also utilized by CPD and CFD, although the full amount of the grant award has customarily been carried on the OEMC's budget lines, as the OEMC has managed this grant. Going forward, all public safety grants will be managed by the new Office of Public Safety Administration.

The following information is provided in response to questions posed at our department's hearing on October 28, 2020 to discuss the proposed 2021 budget.

Alderman Lopez asked for a list of third party 3-1-1 smart phone apps and any related expenses.

There are currently five (5) separate private third party 3-1-1 apps. Their names and the number of service requests that have been submitted via each application in 2020 to date are as follows:

- Chicago Works 2,249 service requests
- SeeClickFix 2.091
- CHITEXT 427
- Windy City 311 9
- Zencity 1

The following information is provided in response to questions posed at our department's hearing on October 28, 2020 to discuss the proposed 2021 budget.

Alderman Hairston asked for expenditure information and MBE/WBE breakdown for court reporter contracts on OEMC's budget line 0140.

OEMC does not participate in the selection of court reporting agencies. The Department of Law handles the selection of court reporting agencies for the City. Individual departments pay their own costs associated with legal fees, such as arbitration costs and court reporters. DOL will send departments invoices for their portion of the contractor's overall bill for review and payment processing.

OEMC has processed \$4,425.18 for arbitration and court reporting under its Fund 100 Account 140 in 2020 as of today. The breakdown is listed below:

- BRIDGES COURT REPORTING \$1,273.98
- DANIEL NIELSEN \$140.00
- PETER R MEYERS \$3,011.20

Such payments going forward will be processed by the new Office of Public Safety Administration. I respectfully refer you to the Department of Law concerning MBE/WBE breakdowns for any court-related contracts. As always, please let me know if you have any further questions.
