

The following information is provided in response to questions posed at our department's hearing on October 14, 2022, to discuss the proposed 2023 budget.

Alderman Osterman asked for information on the Right to Counsel Pilot.

The Chicago Department of Housing launched a three-year citywide Right to Counsel (RTC) Pilot Program, supported by \$8 million of Emergency Rental Assistance Program 2 (ERAP2) housing stabilization funding. The purpose of this program is to increase housing stability by providing free legal services to low-income tenants who are at risk of eviction or facing eviction. The RTC Pilot Program services will be provided through two legal aid groups, one led by the Lawyers' Committee for Better Housing alongside Legal Aid Chicago and the Coordinated Advice and Referral Program for Legal Services (CARPLS); and the other through Beyond Legal Aid, both selected through a Request for Proposals (RFP) issued by DOH in November 2021. Both contracts are awarded on a one-year basis, renewable for up to two additional years, at the discretion of the City based on the respondent's performance. The RTC Pilot Program launched on September 1, 2022.



BACKGROUND

The COVID-19 pandemic and related economic fallout has created massive housing instability across the country. Chicago residential eviction court records of cases filed during the calendar years of 2017-2020 show a vast imbalance in rates of representation between landlords and tenants. When renters face the loss of their home in housing court, legal representation makes a critical difference. Without an attorney, the likelihood that an eviction order will be entered against a tenant is 62%; with an attorney, it drops to 45%. In other words, legal representation decreases the odds of getting an eviction order by about 25%.

The benefits of having an attorney are even greater when the tenant is represented by a civil legal aid provider, a non-profit organization that offers free legal help with non-criminal legal issues. 50% of cases where tenants were represented by private attorneys resulted in eviction orders. Legal aid representation resulted in eviction orders only 22% of the time, less than half the rate of their private attorney counterparts.

The Chicago Department of Housing recognizes that one of the leading interventions to preventing evictions is providing legal assistance to at-risk tenants. As a result, DOH released a Request for Proposals for the Right to Counsel pilot program in November 2021 and applications were reviewed by an evaluation committee of six trusted leaders in the community.

AWARDS

In April 2022, DOH announced the selected firms, Lawyer's Committee for Better Housing and Beyond Legal Aid. The Lawyers' Committee for Better Housing will receive a contract for providing full scope and limited-scope legal representation at no cost to eligible low-income tenants at risk of or subject to eviction in Chicago. The Lawyers' Committee for Better Housing's total anticipated award will be at least \$7.1 million over three years.

Beyond Legal Aid will receive a contract for providing legal services through their network of community-located, community-operated, and community-directed legal aid programs. Beyond Legal Aid's total anticipated award will be up to \$900,000 over three years. Both contracts cover full-scope and limited-scope legal representation and services.

The Chicago Department of Housing will continue to search for additional private and public funds to expand this initiative.



PROGRAM ELIGIBILITY

Chicago residents facing eviction can access free legal services citywide through our Right to Counsel partners, Beyond Legal Aid and the Lawyers' Committee for Better Housing.

To be eligible, tenants must meet all four of the following criteria:

- 1. Have an income less than or equal to 80% of the area median income based on household size.
- 2. Be a tenant currently residing in a property intended for residential use.
- Be part of a household in which one or more individuals have experienced a reduction of household income, incurred significant costs, or experienced other financial hardship during or due, directly or indirectly, to the coronavirus pandemic.
- 4. Be part of a household where one or more individuals can demonstrate a risk of experiencing homelessness or housing instability.

EVALUATION

The Chicago Department of Housing has been awarded \$300,000 from the Polk Foundation to fund an evaluation of the Right to Counsel Pilot Program. DOH is working closely with the Chicago Bar Foundation and Stout, a Chicago company, to conduct a 3-year cost benefit-analysis of the RTC pilot. Stout has the capacity to develop a comprehensive, sustainable data platform to identify the fiscal, financial, and community impacts of eviction prevention and defense. It has the potential to transform our current understanding of the critical importance of providing legal representation and other supportive services to low-income tenants facing eviction.
