The following information is provided in response to questions posed at our department's hearing on October 20, 2022, to discuss the proposed 2023 budget.

Chair Dowell asked for a breakdown of the 2022 reported hate crimes by those involving crimes against property and those involving crimes against people.

Of the 77 reported hate crimes received by the Commission on Human Relations from the Chicago Police Department, 15 involved crimes against property and 62 were crimes against people.
