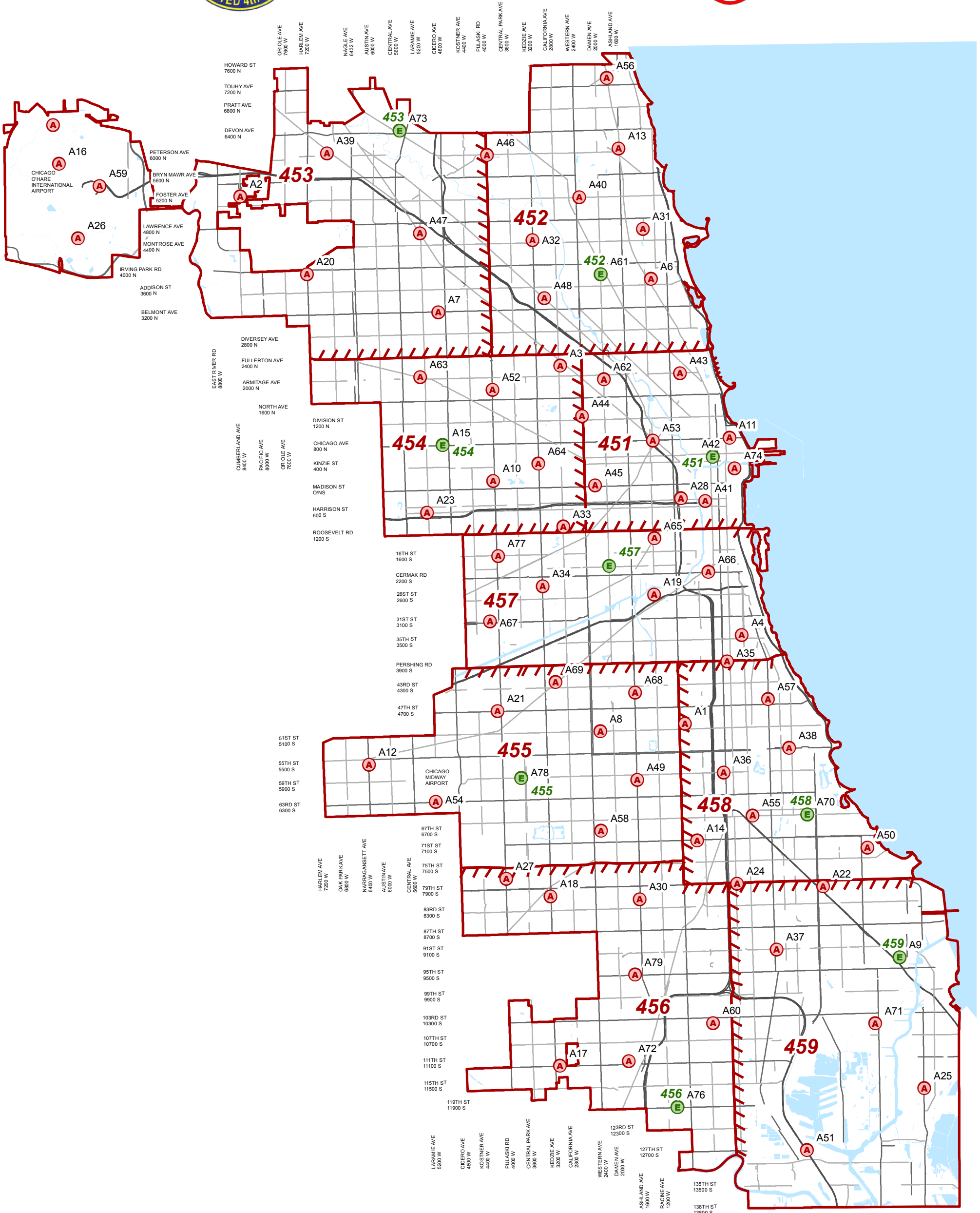

The following information is provided in response to questions posed at our department's hearing on 10/20/2022 to discuss the proposed 2023 budget.

Alderman Vasquez asked for the dollar amount of federal funds that go to CFD and where they go. The Alderman also asked about what has been explored for funding for ambulances.

In the FY23 budget, CFD has \$66,301,000 in grant funds. This budgeted amount consists of multi-year programs that will carry over into 2023, and not just new grant funds. Please see attached one-page summary on the programs and several vehicle allocations highlighted.

CFD, the Office of public Safety Administration (OPSA), and the Department of Assets, Information and Systems (AIS) meet routinely reviewing all potential funding avenues between capital funds and grants. The departments prioritize equipment orders to capitalize on any potential new grant awards and ensure vehicles can be ordered and delivered timely. CFD has been successful in funding some vehicles out of grants whenever eligible, and in addition to the attached grants, CFD has worked through the Foreign Fire Insurance Board (FFIB) to place orders for other critical vehicles such as pumps and hazardous materials trucks which are expected to be delivered Q2 2023.

CFD will continue to explore grant opportunities and submit applications whenever applicable.

Grants General

CFD Grants increased from FY22 to FY22 by \$6,129,850 due to anticipated higher UASI award to CFD next year. Any individual decreases in grants are due to routine spend down or grants expiring.

Port Security Grant Program (federal)

- Department of Homeland Security federal grant for terrorism preparedness and response on the waterways
- Competitive Grant
- CFD spends money on equipment, training, and exercises for the CFD marine unit (Air Sea and Rescue)
- This is a competitive grant and when projects are awarded, CFD has been successful in obtaining Port assets such as a new specialized boat this year in 2022.

Urban Areas Security Initiative (UASI) (federal)

- Department of Homeland Security federal grant for terrorism preparedness and response
- Program started in 2003 in response to Sept 11th
- Formula grant, money determined by DHS based on various factors like threat and population
- CFD spends money on equipment, training, and exercises for the CFD Special Ops teams and Sim Lab
- This year CFD was able to place orders for 2 hazardous materials trucks using UASI funds that will be delivered next year. These trucks will support active shooter, terrorism, complex attack response.

Securing the Cities (federal)

- Department of Homeland Security Domestic Nuclear Detection Office federal grant
- Program provides radiological/nuclear detection equipment and training
- STC began in 2006 as a pilot in New York, added LA in 2012, added DC in 2014, added Houston in 2015 and added Chicago in 2016. In 2020, six new cities were added: Atlanta, Denver, Miami, Phoenix, San Francisco, and Seattle.

Mobile Integrated Health Unit

- Private grant funded by the Medical Home Network to fund 2 vans to support the CFD Mobile Integrated Health Unit.

Assistance to Firefighters Grant (federal)

- Competitive FEMA preparedness fire safety grant to fund critically needed resources to equip and train emergency personnel, enhance efficiencies and support community resilience.

Fire Academy Training and Improvement (State grant, through State Fire Marshal)

- State formula grant to support the fire training academy personnel, equipment, training and supplies.
- This year CFD was able to allocate a portion of these grant funds towards a CFD ambulance prop for the new public safety training campus.

The following information is provided in response to questions posed at our department's hearing on 10/20/2022 to discuss the proposed 2023 budget.

Alderman Martin asked about mental health visit session caps.

Medically necessary mental health services are covered by the HMO and PPO, including in-patient, outpatient and professional services. The PPO plan and HMO plans have different referral and review requirements but neither the HMO nor the PPO have a cap on services in so far as the member follows plan terms. There is no lifetime benefit limit on medical services in either plan.

Depending on which medical group an HMO member has selected as their primary care physician, the member may need a referral from the primary care physician for mental health services. Not all medical groups require a referral; some medical groups allow self-referral to mental health services. Out of network services, or services for which no required referral was obtained may be denied. There is no cap on the number of medically necessary out-patient therapy sessions.

In the PPO, members may self-refer for mental health services. If the member uses an in-network provider, the member will pay less than if they use an out-of-network provider. After the first ten sessions of out-patient therapy in any plan year, the provider must call to obtain pre-certification of further services. There is no cap on the number of medically necessary therapy sessions.
