The following information is provided in response to questions posed at our department's hearing on October 18, 2023, to discuss the proposed 2024 budget.

Alderman Ervin asked for what the \$1.5M of CDBG-Cares funds were going towards.

AEC was awarded a \$4M CDBG grant for rehab/renovation of 2 health centers (Englewood and MLK). The grant's start date was on 3/1/2020 and the end date is 9/30/2027. AIS provided OBM with the 2023 grant carryovers dollars for the 2024 budget. At the time, AIS still had \$1.5M. available, however, AIS was in the process of reviewing invoices and had subsequently spent all the available funds besides \$75k. AEC plans to use the remaining funds by the end of the year.
