The following information is provided in response to questions posed at the Police Board's hearing on October 17, 2023, to discuss the proposed 2024 budget.

Alderman Taylor asked how many officers resign before a ruling is given in a CPB case.

Since January 1, 2019, 24 officers have resigned from the Chicago Police Department prior to a full Police Board hearing on the charges. There have been 59 full Police Board hearings since 1/1/2019.
