Alderperson Dowell requested the number of officers being added to the hijacking team.

There are Citywide and Area Vehicular Hijacking teams with officers added as needed based on ongoing monitoring and evaluating of trends. However, as of 11/7 there are 93 CPD personnel dedicated to vehicle hijacking. The breakdown of the 93 personnel goes as follows: 1 LT, 8 Sgts, 73 POs assigned as Det, and 11 POs.

The following information is provided in response to questions posed to the CPD during the 2024 CPD Budget Hearing of the City Council on October 24, 2023.

Chairman Ervin and Alderperson Reilly requested the difference between the 427 and 429 type helicopters. Price/Time it takes to procure, activate them.

The two helicopters are as follows:

407 is a single engine helicopter. All in (including helicopter and equipment) cost is roughly \$5.9 million 429 is a twin/ dual engine helicopter. All in (including helicopter and equipment) cost is estimated \$11 million.

The city is currently working to procure two 407 single engine helicopters. These are expected to arrive in Quarter 4 of 2024. We had to work through the entire contract process. There is a long lead time for the 407 production.

The 429 twin engine helicopter can be built faster and available by Q2 2024 (i.e. before summer). This is due to the fact that the production line for the 429 is shorter than the 407. The city would need to go through the contract process.



Funds from seizures are distributed back to CPD in accordance with 725 ILCS 150/13.2 (1) (i), which states "65% shall be distributed to the metropolitan enforcement group, local, municipal, county or State law enforcement agency or agencies that conducted or participated in the investigation resulting in the forfeiture." Once the cases are adjudicated and the monies/items become forfeited, Illinois State Police remits 65% back to CPD for deposit into a 1505 account. Note that the Bureau of Counter-Terrorism administers the account since the Bureau is responsible for conducting the majority of narcotic-related investigations.

Please see attached breakdown as to how the funds in the 1505 Account have been utilized year to date.

Alderperson La Spata requested the definition of a "traffic mission" and the reason they are deployed.

Traffic missions are a tool the Department and Bureau of Patrol (BOP) use to address crime and traffic safety concerns. BOP sends the top 3 locations in each district where data has shown the most vehicular traffic accidents occur. This data is provided to the BOP by CDOT, and locations are distributed daily to all districts. In addition, traffic missions are used to combat violence in high crime areas. Personnel are provided with information on recent crime trends including, but not limited to, robberies, Motor Vehicle Thefts, and shootings. Information provided includes intelligence on wanted offenders, wanted vehicles, patterns, locations, and times. Officers utilize this information so they can make constitutional stops. Officers routinely use License Plate Readers (LPR) to support these missions. LPRs are instrumental in helping recover stolen vehicles and vehicles taken in vehicular hijackings. Recovering these vehicles quickly is vitally important before they can be used in secondary crimes such as robberies and shootings. Traffic missions are routinely conducted at the request of community members to address localized issues as well.

Outside of Patrol, CPD has a dedicated unit, Major Accident Investigation Unit (MAIU), that investigates traffic crashes with serious personal injury likely to cause death, fatal traffic crashes, and hit-and-run incidents.
