Substantial Amendment to the 2010-2014 Consolidated Plan

Public Comment Period: October 20, 2014 to November 20, 2014

The City of Chicago, through the Office of Budget and Management, has prepared a substantial amendment to update the 2010-2014 Consolidated Plan (ConPlan). The substantial amendment revises the projected performance outcomes for the City's 2010-2014 ConPlan for grant funds awarded by the U.S. Department of Housing and Urban Development (HUD) for the Community Development Block Grant (CDBG), the Emergency Solutions Grant (ESG), the HOME Investment Partnerships Program (HOME) and the Housing Opportunities for Persons with AIDS (HOPWA) programs.

The ConPlan is carried out through annual Action Plans, which provide a concise summary of the actions, activities, and specific federal and non-federal resources that will be used to address priority needs and specific goals. Prior notifications of the revisions included in this substantial amendment were included in Actions Plans submitted to HUD in years 2010-2014.

1. Summary of Consultation Process

The City developed this substantial amendment to inform the public of these changes and to allow for a public comment period.

2. Summary of Citizen Participation Process

The City believes that citizen participation is central to the success of community development. To that end, the City makes this substantial amendment available for public review for 30 days beginning on October 20, 2014, and ending on November 20, 2014.
