July 2025

This report offers a detailed "point-in-time" of the City's revenues as of July 2025, the seventh report of the fiscal year which extends from January through December 2025. It provides a glance at our revenue streams and sets the stage for our financial management throughout the year.

Some of the City's revenues experience a lag between the time the underlying economic activity occurred, and when the resulting revenue is collected. Further, seasonality in some revenue streams and the irregular nature of others may lead to significant variances from one month to the next.

MONTHLY ANALYSIS

Budgeted revenues through July total \$2,446.1 million or 45% of the fiscal year 2025 total. Actual revenue collections year-to-date are \$2,573.6 million, \$127.5 million or 5.2% above budget.

Utility Taxes include taxes such as natural gas, electric, telecommunications, and cable. For this category, natural gas pricing and usage has led to revenues exceeding budgeted expectations. Additionally, Income Tax also exceeded expectations through higher capital gains and interest earnings during tax year 2024. Internal Service Earnings, or reimbursements to the Corporate Fund from other city funds, are ahead of schedule and should return to budgeted levels by year end. Chicago sales taxes are down due to a state policy change that transfers revenue from the use tax category (local tax revenue) to state sales tax (proceeds and transfers) revenue.

Other revenue includes surplus revenues from Tax Increment Financing (TIF) districts, which uses property tax revenue to invest in specific areas through various projects. When these districts expire or spend less than expected, it leaves more surplus than anticipated.

Transaction Taxes exceed expectations due to the Personal Property Lease Transaction (PPLT) tax. PPLT revenue comes from leasing personal property like equipment and automobiles but the primary driver of the positive results stems from cloud-based storage as the industry growth and product demand has continued to exceed expectations.

As for PPRT, per the Illinois Department of Revenue, PPRT revenues are collected by the state of Illinois from corporations, partnerships, and trusts and paid to local governments to replace money that was lost by local governments when their powers to impose personal property taxes on these business entities were removed. State estimates for PPRT revenue allocations are down nearly \$1 billion from last year as the state diverts, transfers, and trues-up tax revenues from PPRT.

OBM will continue to monitor revenue performance to determine if any adjustments within the fiscal year budget are necessary.
