I. OLD TOWN DISTRICT

LOCATION:

An area of approximately 56 acres described on the attached map one
(1) and generally bounded by North
Clark Street, West Eugenie Street,
North Wells Street, West North
Avenue, North Mohawk Street, and
The Ogden Mall, Chicago, Illinois
60614.

DATES OF DEVELOPMENT:

1850's through present day (predominantly 1880's and 90's)

SIGNIFICANT STRUCTURES:

Among the approximately 500
structures, there are several
buildings and developments of high
landmark quality: St. Michael's
Church, five row houses on Lincoln
Park West by Louis Sullivan, The
Fredrick Wacker residence on Lincoln
Park West, the 1700 block of North
Lincoln Avenue, and the rowhouses
and apartments of Crilly Court.

PRINCIPAL LANDMARK
DISTRICT CRITERIA:

The district is a virtually intact example of a typical Chicago middle

class neighborhood of the late 19th century. It contains a variety of Styles within the scale of small residences, apartments, and commercial structures. The district also exhibits continuous sections of rowhouses and apartments that reflect the unified work of single developers.

Excerpt from Municipal Code of Chicago, Section 21-64

"(c) Upon reaching a preliminary conclusion that an area, place, building, structure, work of art or other similar object meets one or more of the criteria contained in subsection (b) hereof, the Commission shall advise the Commissioner of Development and Planning of the City of Chicago of said conclusion and secure from said Commissioner his recommendation with respect to the relationship of the proposed designation to the Comprehensive Plan of the City of Chicago, his opinion as to the effect of the proposed designation upon the surrounding neighborhood, and his opinion and recommendations as to any other planning considerations as may be relevant to the proposed designation, together with his recommendation of approval, rejection or modification of the proposed designation."

II. RELATIONSHIP OF THE PROPOSED DESIGNATION TO THE COMPREHENSIVE PLAN OF CHICAGO

The Old Town District is located within the North Communities
Area of the Comprehensive Plan (map 2). It is also within the

Lincoln Park General Neighborhood Renewal Plan area (map 3), as well comprising the bulk of the area of the Lincoln Park Urban Renewal Project One. (map 4).

As one of several neighborhoods within the general Lincoln Park Area, the Old Town District has benefitted from the urban renewal program of rehabilitation and conservation. The effect of these efforts has been, and will continue to be a strengthening of the well-maintained, residential character of the District.

Additionally, the park-mall concept featured in the Comprehensive Plan is having a most fruitful realization along the District's western edge in the Ogden Mall, a specific objective of the Comprehensive Plan.

In a broader sense, under the categories of "Quality of Environment, Urban Design, and Regional Planning", the Old Town District meets the following objectives of the Comprehensive Plan of Chicago:

- (a) "Special care should be taken to preserve and enhance those features and environmental qualities which are important to the metropolitan area as a whole, for example, the lakefront, landmarks, and historic buildings."
- (b) "The most significant design qualities are those which convey a sense of history, importance, and uniqueness to the city."

It is my opinion that the proposed Old Town District fulfills the stated objectives of the Comprehensive Plan to the highest degree.

III. EFFECT ON THE IMMEDIATE AREA

The Old Town District represents a distinct portion of the greater Licnoln Park area that throughout its history has successfully sought to retain its predominently turn-of-the-century character and scale. Designation of the Old Town would recognize these efforts and serve as an additional assurance to the area's continued sympathetic development.

IV. PLANNING CONSIDERATIONS, TECHNICAL COMMENTS AND RECOMMENDATIONS FOR FURTHER STUDY OR ACTION

In an effort to establish the District's unique identity, it is recommended that the District's official name be the <u>Old Town Triangle District</u> so as to differentiate the District from the shopping strip further south along Wells Street. Also helpful would be signs with a logotype that could be attached to utility poles within and along the boundaries of the District which should be designed so as to clearly identify the area.

We recommend that a set of guidelines be set up for the benefit of homeowners desiring to make repairs, restoration, or new construction. Distribution of these guidelines should be made at the time of requesting owners' consent to designation. A method that assures the most efficient processing of building permit applications should be devised. This is due to the large number of agencies with interests in the area: The Department of Buildings, Department of Urban Renewal, Department of Development and Planning, the Chicago Plan Commission, and the Chicago Commission on Historical and Architectural Landmarks. This, and all proceedural issues, should be clearly defined and distributed to owners prior to and also during the necessary public hearings.


It is suggested that the eastern boundary of the District be revised to exclude all of the properties fronting Lincoln Park. This owing to the significant potential for improvements by private developers along Clark Street's Lincoln Park frontage.

On the west, it is suggested the District be extended to include the open play area immediately east of the St. Michael's Convent at Eugenie Street and St. Michael's Court.

Further, it is suggested that all of the residential redevelopment on LINCOLN PARK URBAN RENEWAL PROJECT ONE parcel 48-M be included within the district, rather than only that part of 48-M facing Meyer Court.


V. RECOMMENDATION

It is recommended that the proposed Old Town District be designated as an Official Chicago Landmark, subject to the provisions set forth in section IV of this report.




TENTATIVE BOUNDARIES OF OLD TOWN DISTRICT

LINCOLN PARK GNRP AREA PROPOSED LAND USE PLAN








CONSERVATION BOUNDARY PROJECT No. I BOUNDARY


Re: Old Town Triangle Boundaries
