**PERMIT REVIEW COMMITTEE REPORT TO

The following project was reviewed by the PRC:

1. **5700 S. Lake Shore Drive**
(Museum of Science and Industry – 5th Ward)

Proposal: Proposed expansion of the west parking lot, curb cut modifications, relocation of historic light fixtures and new trash enclosure.

Action: Approved unanimously as submitted.

2. **224 S. Michigan**
(Historic Michigan Boulevard District – 42nd Ward)

Proposal: Proposed reface of the existing non-historic illuminated rooftop “Santa Fe” sign with new illuminated “Motorola” copy on existing structure, detailed in plans dated 3/12/12.

Action: Approved unanimously with the following condition:

1. As proposed, the “Motorola” copy shall be consistent with the existing “Sante Fe” copy in terms of color and illumination levels at night. Should the project scope include painting the existing metal sign structure, which is to remain, the paint color shall be a dark, non-reflective color

3. **1936 S. Michigan**
(Second Presbyterian Church – 3rd Ward)

Proposal: Proposed construction of a new 60” x 102” free-standing changing image sign with 42”-tall masonry base located along the east property line facing Michigan Avenue. The total height proposed is 102”.

Action: Approved with the following conditions (vote was 2 in favor with Commissioner Baird abstaining):

1. The changing image portion of the sign shall be no larger than 60" x 102" and the stone-clad base of the sign shall be no taller than 16" so that the top of the sign is aligned or below the window sill of the historic façade behind the sign (76" total height). Alternatively, a taller, free standing sign would be allowed at the southeast corner of the property or on the north side of the property where there are no windows that would be obscured; and,
2. The proposed stone cladding for the base, with a smooth face and with a slightly different color in comparison to the rusticated stone of the Church facades, is approved as submitted. All electrical transformer boxes, conduit and electrical connections shall be concealed under ground or within the sign or base.
