PERMIT REVIEW COMMITTEE COMMISSION ON CHICAGO LANDMARKS

October 6, 2016

The Permit Review Committee (PRC) met on September 1, 2016, at 1:30 p.m. The meeting was held at 121 N. LaSalle St., in Room 201-A.

The following projects were reviewed by the PRC:

**1. 2128 N. Halsted 43rd Ward
Armitage-Halsted District**

Proposed renewal of a previous conditional approval for removal of a non-historic staircase, masonry wall, and front entry and replacement with a new masonry and limestone straight-run stair and new recessed entry with double doors and a transom window

Action: Approved unanimously with the following conditions:

1. The transom window above the door shall have a bottom rail matching the top rail dimension;
2. Panels on doors and door surround shall be recessed;
3. As proposed, masonry and the historic basement window exposed by removal of the existing stairs shall be cleaned, repaired as needed, and tuckpointed. Chemical cleaning product information shall be provided with the permit application; and,
4. Samples of new brick and masonry to be reviewed and approved by Historic Preservation staff prior to order and installation.

**2. 4520 N. Broadway 46th Ward
Proposed Uptown Square District**

Proposed replacement of deteriorated terra cotta masonry units with painted limestone on a corner 3-story mixed-use building.

Action: Approved unanimously with the following conditions:

1. Given the extent of the existing painted terra cotta on the building, the use of painted limestone as a replacement material for the historic white-glazed terra cotta may be approved, provided that the limestone units have polished surface and can be coated to match the historic color and finish of the terra cotta; and,
2. Per the mock-up reviewed by staff the applicant may use Edison Coating Elastowall-351 as a base coating and Aquathane-UA 210 as the top coating to match the color and reflectivity of the historic terra cotta. All products are to be applied per manufacturer's specifications.

**3. 3406 S. Calumet
Calumet-Giles-Prairie**

4th Ward

Proposed new, two-story, masonry, single-family residence and detached, one-story, rear garage

Action: Approved unanimously with the following conditions:

1. The front stair knee walls shall be reduced in height and incorporate an open metal railing to be more in keeping with the architectural character of historic front stairs in the district;
2. Window details, front door cut sheets, and enlarged details of the parapet/eaves and porch/stair/railings shall be included in the permit plans; and,
3. Masonry unit size, color, and texture shall be compatible with district characteristics and samples shall be provided for staff review and approval prior to order and installation.

**4. 2229 S. Michigan
Motor Row District**

3rd Ward

Proposed exterior alterations including new storefronts, new windows, a new canopy, and a projecting blade sign for an existing 3-story masonry building.

Action: Approved unanimously with the following conditions:

1. The storefront configuration should be modified so that either the intermediary vertical mullions under the transom are butt-glazed or the intermediate vertical mullions are reduced from two to one per bay, to be similar in appearance to the historic large display windows typical of the district;
2. All of the storefront glazing, including the panel above the southern storefront entry (with no canopy), shall be clear vision glass;
3. The new upper-floor windows shall be double-hung windows as proposed with enlarged details included in the permit plans for Historic Preservation review and approval;
4. The new rectangular canopy, proposed within the northernmost storefront bay and with exposed bulbs attached to the underside, is approved as proposed; and,
5. The projecting blade sign, proposed to be approximately 18'-6"-tall x 2'-6" wide, and mounted to the flat brick portion of the Michigan Avenue façade is approved with further review for approval of

illumination, materials, enlarged details, and specifications by Historic Preservation staff prior to permit application.

**5. 939 W. Fulton Market
Fulton-Randolph Market District**

27th Ward

Proposed restoration and rehabilitation of 2-story timber-framed masonry building, including new windows and storefronts and reconstruction of a third floor with a new mechanical penthouse and rooftop deck.

Action: Approved unanimously with the following conditions:

1. Masonry cleaning specifications and repair, and replacement details shall be included in the permit application plans. Samples of any replacement stone, patching, and any new masonry and mortar shall match the historic in size, color, profile, texture and type and shall be reviewed and approved by Historic Preservation staff prior to order and installation;
2. The plans shall be modified to retain and repair the existing historic transom windows if possible, or replace them to match if beyond repair. These transom configurations shall inform the design of the new storefront transoms in size, configuration, and muntin profiles. Any new divided windows shall have substantial profiles with spacer bars. Existing and proposed storefront details with dimensioned exterior profiles shall be submitted with the permit application;
3. As proposed, the existing historic cast iron columns in Bay A shall be retained and reinstalled to accommodate a new storefront system. Since no evidence exists that cast iron columns were historically utilized for the remaining storefronts, columns proposed for new storefront bays may either be simplified in design to not replicate the historic columns or may be eliminated;
4. As proposed, the new second floor windows shall match the existing windows in size, glass size, operation, muntin arrangement and muntin size. Existing and proposed details of exterior profiles and interior spacer bars shall be submitted with the permit application; and,
5. The proposed third floor addition, roof deck and enclosures are approved as proposed. Samples of any new brick, stone, and mullion finishes shall be submitted to Historic Preservation staff for review and approval prior to order and installation.
