Dear Chairwoman Flores,

Uptown United is the nonprofit community economic development organization that serves Chicago's Uptown neighborhood. Our organization supports the passage of the Clark Street Crossroad Corridor Study by the Chicago Plan Commission.

Clark Street is truly a crossroads, bridging many different wards, special services areas, chambers of commerce and economic development organizations. Clark Street between Montrose and Foster has been on the periphery of development pressures for years. As early as 2018, Uptown United reviewed an increasing number of development proposals in and along the Clark Street corridor; however, lack of a cohesive vision for the corridor posed challenges for each entity to provide support.

In both 2018 and 2020, Uptown United advocated the Alder offices and DPD for an official planning effort funded by the Clark/Montrose TIF. From a January 2020 letter to Commissioner Cox: "We envision that this plan will guide the various stakeholder groups, residents, private developers, and the City of Chicago in their decision-making process for development in this corridor. This study could provide a common framework across the various jurisdictions that serve this area."

For nearly a year and a half, DPD engaged a broad group of stakeholders through virtual and in-person steering committee and community meetings to achieve what we advocated for: a framework the many stakeholders can use to facilitate thoughtful, meaningful development along this diverse corridor. It is understood that a framework is a guide for future implementation and not definitive decisions. Uptown United views the Clark Street Crossroads Corridor Study as a critical first step in initiating much-needed reviews of city policies.

Uptown United was encouraged to see "Increase Predictability and Consistency of Project Review and Approval Projectsing "the Projectsing Confidence Confid

Since 2018, Uptown United has requested clear, consistent design and massing guidance that address shifts in development patterns, especially ground floor residential on commercial corridors. We were encouraged by the public input around desired density and aesthetics for new construction and renovation projects. These visual preferences are the first step in providing guidance as we continue to review projects in and near the Clark Street corridor.

Our mission is to build a strong, unified business environment; facilitate economic development; and strengthen community—all to nurture a diverse, vibrant, thriving, and strong Uptown. The Clark Street Crossroad Corridor Study is the first and much needed step in helping us achieve our mission in collaboration with all our neighbors.


I'd like to verbalize my support for the Clark Street Crossroads Project generally, and really make the case for protected bike lanes in that project.

First, bike lanes have been shown in <u>study</u> after <u>study</u> to <u>DRIVE retail traffic</u>. Also, <u>retailers often</u> <u>underestimate</u> the share of shoppers arriving by non-auto modes.

Second, **Chicago has climate goals to reach**, and getting people out of their cars helps with that. According to this 2019 study, transportation is responsible for nearly 30% of Americans' emissions, and of that 29.8%, 77.5% of transportation emissions are directly related to private automobile use. The earth is straight up dying - let's try and heal it before it's too late.

U.S. household emissions

Transportation and housing account for more than half of all U.S. household emissions, both at home and overseas.



Lastly, Clark Street was identified as a "spoke route" in the Chicago Streets for Cycling 2020 plan. As you can see below, the top two designs are physically separated and protected lanes for these types of routes:

Spoke Routes

Thousands of people commute to Downtown Chicago on a daily basis by bike. Some of these commuters come from the edges of the City as well as the suburbs. Providing designated commuting routes to the Loop will make it safer and more convenient for employees to bike to and from work.

Spoke Routes are direct routes in and out of the Loop that will provide a safe, continuous bikeway and connect all areas of Chicago with the downtown. The primary goal of the Spoke Route network is to increase bicycle commuting citywide.

The seven Spoke Routes are:

- 1. Clark Street
- 2. Milwaukee Avenue
- Lake Street/Randolph Street
- Archer Avenue
- Vincennes Avenue
- South Chicago Avenue
- 7. State Street/Wabash Avenue

The design of the Spoke Routes will follow the same process as the Crosstown

- Barrier protected bike lanes (preferred treatment)
- Two-way barrier protected bike lanes

Cycling is dangerous for anyone in Chicago, let alone young people or seniors. Let's do something good on Clark with this plan and begin to change how dangerous our streets are for those not in autos.

My name is Ethan Saltzberg, and I would like to leave public comment on the draft plan of Clark Street Crossroads, which the commission will consider for approval on Thursday, March 16th.

I utilize this corridor a lot, whether visiting restaurants like Pick Me Up Cafe or Tiztal Cafe, going shopping, or passing through Clark St to reach other neighborhoods south and north. I drive my car, walk, bike, use e-scooters, and take the 22 Clark bus through this corridor.

The highlight of this plan for me is the land use policies. The frontage in this area is unique and should be built upon, and I think the plan has wonderful recommendations for how to use land that is currently undeveloped, vacant, or in need of rehab, while not affecting existing frontages and businesses/homes already there today. With historic gems like the Issel Building, as well as new and thriving businesses like the Black Ensemble Theatre, these are wonderful policy recommendations and they have my support.

The mobility aspects are wonderful, too. Other areas of Clark St benefit from people-centered design (such as Andersonville just to the north), and this plan prioritizes both safety and livability. The protected bike lanes will keep me and others (especially families) safe on bikes and scooters, intersection improvements will make crossing the street safer for pedestrians, and bus improvements will make traveling to and through this corridor speedier. I think the amount of time and research involved in workshopping the street layout (such as parking studies) has warranted the changes recommended in this plan, and they should be approved in full.

Lastly, I absolutely love the people-focused "public realm" activiations in this plan. Little plazas on side streets are absolutely underrated opportunities to make attractive public space in a grid-shaped city like Chicago, and the attention to outdoor dining and green infrastructure will both make this corridor an even more attractive place to live and visit. The ideas here may be bold, but I think that's exactly what this corridor needs to attract more businesses and residents to this area while keeping the neighborhood character.

I am writing in regards to the Clark Street Crossroads Corridor project. I am a small business owner of 2 chicago businesses, and one of them is located at 5137 N Clark. I am also an avid biker and advocate of safe bike lanes. However, the proposed parking removal for protected bike lanes on Clark street is extremely concerning to me. Removing half of the parking in our area would have a devastating effect on my small business. It would endanger the Andersonville businesses located South-of-Foster, and alienate them from the rest of the community. While I'm typically in support of more bike lanes, removing parking in a busy shopping district does not make sense. We could use this type of bike lane on Ashland — a road that could actually be used as a thoroughfare and doesn't struggle from lack of parking, rather than the bustling Clark Street district.

Please, speak to and visit with some of the small business owners in the area that would be affected. No one from the city has attempted to contact me about this, and my business would be absolutely devastated by it. After 11 successful years in business, I believe this would likely cause us to close.

Hello!

My name is Nihal Dantluri and I am a resident of the 47th Ward. I live on the west end of the ward, so my visits to Clark Street are mostly confined to days I am not working, which is often on the weekend!

In the past, I have typically drove my car to Andersonville/Clark due to the biking infrastructure on Clark to be less than adequate to be safe. Usually, it is quite difficult to drive to Clark due to the high amount of congestion, so I would welcome biking as an option to visit the business corridor.

I am in strong support of removing parking from one side of the street to accommodate protected bike lanes up and down Clark. Personally, I would visit the corridor much more if protected bike lanes are installed, because it would mean less time sitting in traffic, and it would make it much more of a destination. I hope the CPC follows through with the plan of PBL's, because I think the increased traffic from them could help local businesses.

Truthfully, I don't believe that removing one aide of parking on Clark would cause the corridor to lose customers that are drivers. I don't believe that drivers won't go to a specific neighborhood because it is hard to park there, which it already is along Clark, so removing one side of street parking would not change much.

I believe this would benefit the neighborhood a great deal and look forward to the PBL's!

I also think CDOT people's spots could be incorporated onto Clark more often as well!
