My name is Eduardo Ortiz. I live at 2817 S. Kildare, Apt. 2A. Chicago, IL 60623. I am submitting the following comments for the scheduled Planning Commission meeting on Thursday, April 21, 2022 with regards to Agenda Item #4, the Encuentro Square Project, 1800-1840 N. Hamlin Ave. / 1821-1857 N. Hamlin Ave. / 3735-3759 W. Cortland St. / 1820-1856 N. Ridgeway Ave.

Hello, my name is Eduardo Ortiz and I am a current employee at LUCHA, Latin United Community Housing Association. As a proud employee for the past 15 years, I am writing to express my concern about the proposed affordable housing development called "Encuentro Square" in the 26th ward and the continued need for stronger, better paying jobs for the Logan Square Community.

Every day, I work hard to maintain LUCHA buildings and ensure that residents and their families are safe in their homes. I fulfill work orders, transport heavy materials by myself, and am expected to use my own vehicle and gas to buy and deliver materials from stores to the site. I love my job as I get to help families that face similar situations and challenges like mine - families that work hard to better their future but are still hardly making ends meet. Despite our hard work, LUCHA is paying my coworkers and me far below the prevailing rate for our work - some of them having worked for the organization for 15 years and only making minimum wage.

That is part of why every LUCHA maintenance worker has signed a petition asking LUCHA to respect our decision to come together and have a voice on the job. A union job means we will finally have a wage that reflects our work and benefits that support our families. For me, I will be able to save for my children's studies, catch up on bills that I have fallen behind on, and finally get to live life. We have asked LUCHA to recognize our request for union representation, but they have not done so. This is especially concerning given the millions of dollars in public support LUCHA is getting for the project Encuentro Square. This is why we are asking for the development to be delayed. As a Commission, your decision should take into consideration the quality of jobs and economic impact this development will have on the community beyond the construction phase - should a development receive millions of dollars in public support and only pay their workers minimum wage with no retirement benefits and a poor health insurance plan?

I have a family of six and take care of my elderly parents. My family means the world to me, and beyond my job at LUCHA, it is my job to provide the best life possible for them. To do that - I have to fight for what is right. LUCHA workers deserve to be paid for their hard work, and I am urging the Committee to delay the Encuentro Square development so my co-workers and I can join together and have a voice on the job.

I appreciate your time today and hope you will consider this request - Chicago working families are depending on it.
