In November of 2019 a young woman was killed by the driver of a truck just SE of this location on Milwaukee. Six Corners is currently not particularly pedestrian friendly and many are asking for parking spaces so they can drive here. Surely we need to address better pedestrian and cycling access first, more cars will lead to further disruption. As this development and the one at the Sears building are being constructed at the same surely their is an opportunity for cooperation that will benefit all. A pedestrian bridge or underpass seems like a no brainer or at least better consideration of the road layout and crossing options.

I also ask that physically separated cycle lanes are installed, maybe with their own crossing advantage at the lights, similar to the system at six corners Milwaukee, Damen and North. Cyclists and pedestrians would benefit from safer and more efficient crossing and we also gain an opportunity to use planters as both barriers and ways to beautify the area

As construction is taking place we will see an increase in large construction vehicles and I assume lane closures. Please ensure the cycle lanes are maintained during this time. One life was lost recently and we need to take this opportunity to ensure no one else is killed.
