

# **EXISTING CONDITIONS**

Cicero Avenue is a car-centric corridor with safety and accessibility issues for all roadway users, including pedestrians, bicyclists, transit riders, and drivers.

- Intersections throughout the corridor are unsafe.
- Pedestrian safety is a top concern.
- Safer crossings and ADA improvements needed.
- High vehicular speeds are a safety issue.
- There is a lack of transit amenities and transit user waiting areas.
- Cycling across Cicero is uncomfortable due to wide intersections.
- More people would walk, bike or take transit if safety improvements were implemented.
- The corridor serves as a gateway to the City but lacking amenities.

Land use similarly follows an auto-oriented pattern, with smaller-scale development set back behind surface parking.

- Vacant and underutilized properties are seen as detracting from the health of the corridor.
- Stakeholders would like to see new retail, dining, entertainment and green space.
- A lack of businesses and attractions encourage higher speeds and no reason for drivers to stop.
- Strong desire to elevate the corridor's assets, including the airport, businesses, houses and established organizations.
- Programmed, maintained, and well-designed green space could enhance the character of the area.



# **CORRIDOR FRAMEWORK**

Study identifies a series of "character zones" with varying land uses, building patterns and character elements

The Northern and Southern Gateways
 Increased visibility and larger sites/uses. Building frontages C
 generally setback further from road. Planted medians and
 wider outer vehicle lanes in southern portion.

### The Community Commercial

Finer-grain mix of building and business types, many of which are independent or smaller/more local chains. Building frontages generally closer to road. Planted medians throughout.

• Midway Airport Zone


Defined by transportation infrastructure and airport uses. Large landscaped parkway on the west side of the roadway. Building frontages set back from road. Mixture of painted and planted medians, large landscaped parkway, and wider outer vehicle lanes.





# **STREET SECTION IMPROVEMENTS**

- The study examined existing street crosssections along the corridor and presents concepts for increased pedestrian and vehicular safety.
- The study uses a toolbox of placemaking elements to promote walkability, safety, better connectivity for all roadway users, greening and an urban design theme for the corridor.

# **URBAN DESIGN THEMES**

- Three placemaking themes were created through a comprehensive process that included insights from past community efforts and community feedback.
- The result was the development of three distinct themes (or families) of placemaking elements to support the visual identity of the Cicero Avenue Corridor.

### Theme 1: The Way to Midway

#### COMMUNITY INSIGHTS

- · Corridor is direct way to get to airport
- Signage and wayfinding should clearly tie corridor to Midway Airport
- "Midway Airport is part of a neighborhood, you can walk to it"







### Theme 2: The Gateway to Chicago

#### COMMUNITY INSIGHTS

- "Corridor is a gateway to Chicago"
- Highlight Chicago's institutions and major events
- "Area is quintessentially Chicago"



- Created a series of conceptual site development scenarios that articulate best practices for land use, site planning, and public realm activation along the corridor






# **DESIGN GUIDELINES**

### **Categories:**


- Public space
- Program

Active Uses. Encourage active ground floor uses with placemaking elements such as public art, seating, and landscaping that connect the interior and exterior of buildings.




**Site Landscaping.** Incorporate landscape areas near active uses such as main entrances, public spaces, and amenity areas to enhance the public realm.

• Increase landscaping areas to define edges, enhance and direct views, and promote pedestrian use and enjoyment.




**Placemaking.** Utilize placemaking efforts to attract users such as public art, landscaping, seating, and programming.



**Pedestrian Connections.** Enhance pedestrian connections through and between sites to improve pedestrian safety and comfort along the corridor.

- Sidewalks and pedestrian pathways must be well maintained and include safe, clear travel ways throughout the entire year.
- Boost pedestrian activity through public and private realm accommodations.

### If you want to improve the public realm...

#### Special Service Area (SSA) Program

Special Service Areas, known as Business Improvement Districts or BIDs in other cities, are local tax districts that fund expanded services and programs through a localized property tax levy within contiguous areas. The enhanced services and programs are in addition to those currently provided through the city.

SSA-funded projects typically include but are not limited to: public way maintenance and beautification; district marketing and advertising; business retention/attraction, special events and promotional activities; auto and bike transit; security; façade improvements; and other commercial and economic development initiatives.

The city contracts with local non-profits, called Service Providers, to manage SSAs. Mayorally-appointed SSA Commissioners for each SSA district oversee and recommend the annual services, budget and Service Provider Agency to the city. There are currently 56 active SSAs in Chicago.


