- Established Participation Goals:
  - 26% MBE
  - 6% WBE
  - 50% City Resident Work Force (Local Hires)

## Plan Commission Approvals – Through November 2020

- 169 Projects
- \$30,238,955,050 in Total Estimated Project Costs
- 93,937 Construction Jobs
- 100% of the Projects Committed to meeting the goals:
  - 26% Minority Business Enterprise Participation
  - 6% Women Business Enterprise Participation
  - 50% City Resident Hiring



# Executive Order 2017-2 Update

## Part II Permit Review Data – Through November 2020

- 82 Part II Zoning Reviews completed
- \$6,281,337,633 in Total Estimated Project Costs
- 19,028 Estimated Total Construction Jobs
- Proposed Participation Levels at Part II Review:
  - 24.9% Minority Business Enterprise Participation
  - 5.8% Women Business Enterprise Participation
  - 48.2% City Resident Hiring (including 4.2% from Ward)



# Executive Order 2017-2 Update

## Certificate of Occupancy (COO) Data – Through November 2020


- 20 Final COOs issued (+ 8 Partial COOs)
- 14 Final Reports Filed to date
- Final Participation Levels at COO (based on 14 filed reports):
  - \$634,335,919 Total Project costs
  - 21.4% MBE Participation (\$52,082,339 value of work)
  - 7.3% WBE Participation (\$9,369,640 value of work)
  - 37.5% City Resident Hiring (including 89 Ward residents)

Based on Data from Final Reports filed through 11/30/2020




