## GUIDELINES FOR COMPLETING PART ONE OF THE APPLICATION

Part One of this Application provides general information to the Plan Commission for use in preparing its public notices of the proposal set forth in the Application and in preparing its review of that proposal.

1. The date entered in I. should be the date on which the Application is filed.
2. The location of the site of the proposal should be given by street address; if there is no address, the location must be described in relation to existing streets, rights-of-way or other fixed points of reference.
3. The Applicant must state his own name, address and telephone number and the name, address and telephone number of the owner of the subject property. The Applicant must be either the owner of the subject property or his duly authorized agent or representative, and, if the Applicant is an agent or representative, the Applicant must submit proof to the Commission that he is authorized to represent the owner of the subject property.

## GUIDELINES FOR COMPLETING PART TWO OF THE APPLICATION

All graphic materials must be submitted in an 8.5" x 11" format and must be suitable for clear and sharp, black and white reproduction. Each map or diagram should have a scale and a north arrow. Each sheet of graphic material must be labeled with the appropriate figure number. If there are multiple sheets comprising one figure - for example figure 4 - those sheets should be labeled consecutively, for example Figure 4-1, Figure 4-2, etc., and each sheet should contain the address of the site of the proposal in the lower left corner.

For Figure 1, the Applicant should consider the "vicinity of the site" to be at least as extensive as the area for which he is required to give notice plus any intervening streets or other public rights-of-way.

For Figures 3 and 4, the Applicant should consider that "recreation areas" and "recreation space and facilities" include game courts, swimming pools and pool areas, game rooms, exercise rooms, party rooms, community rooms, observation decks and sun decks.

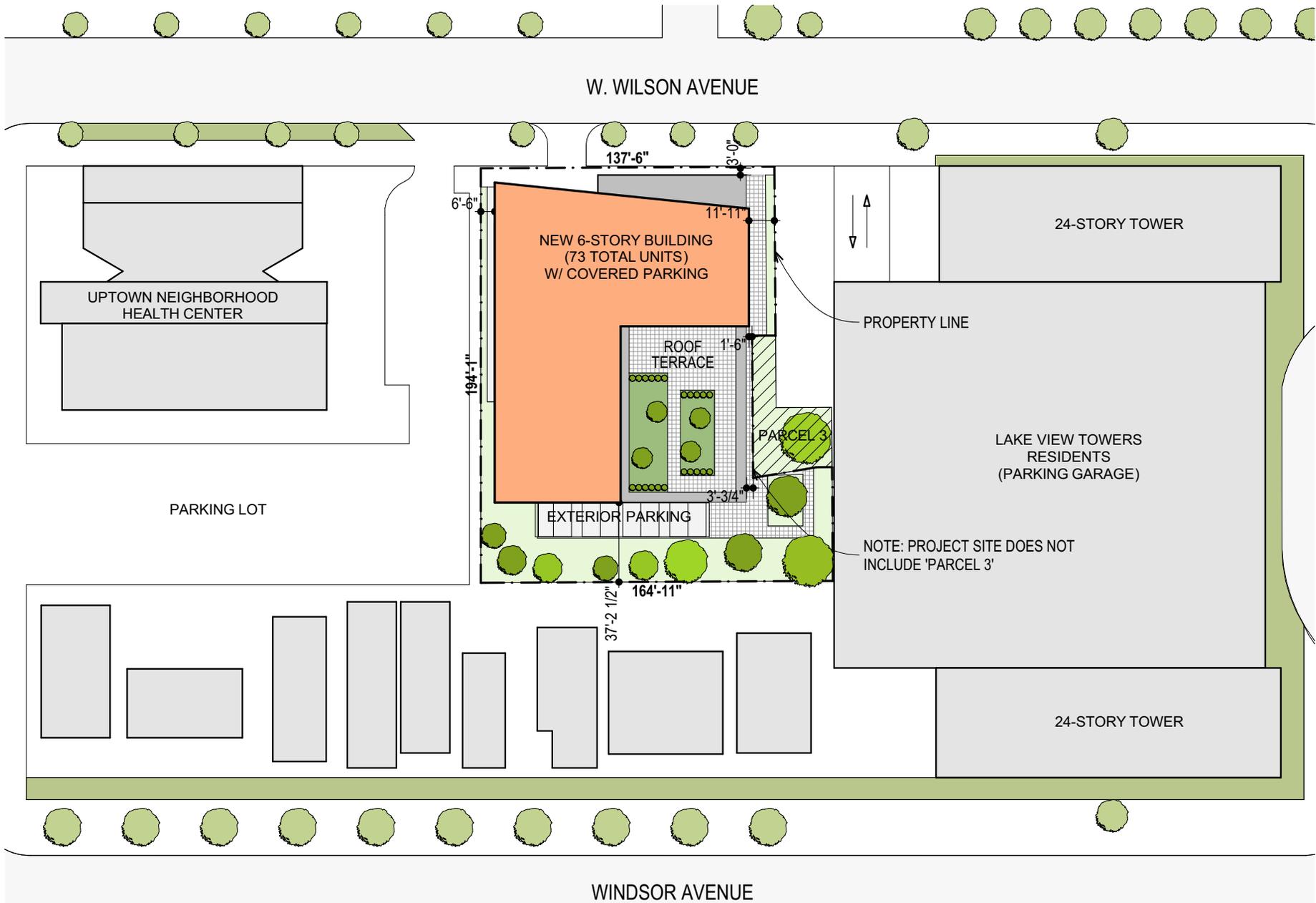

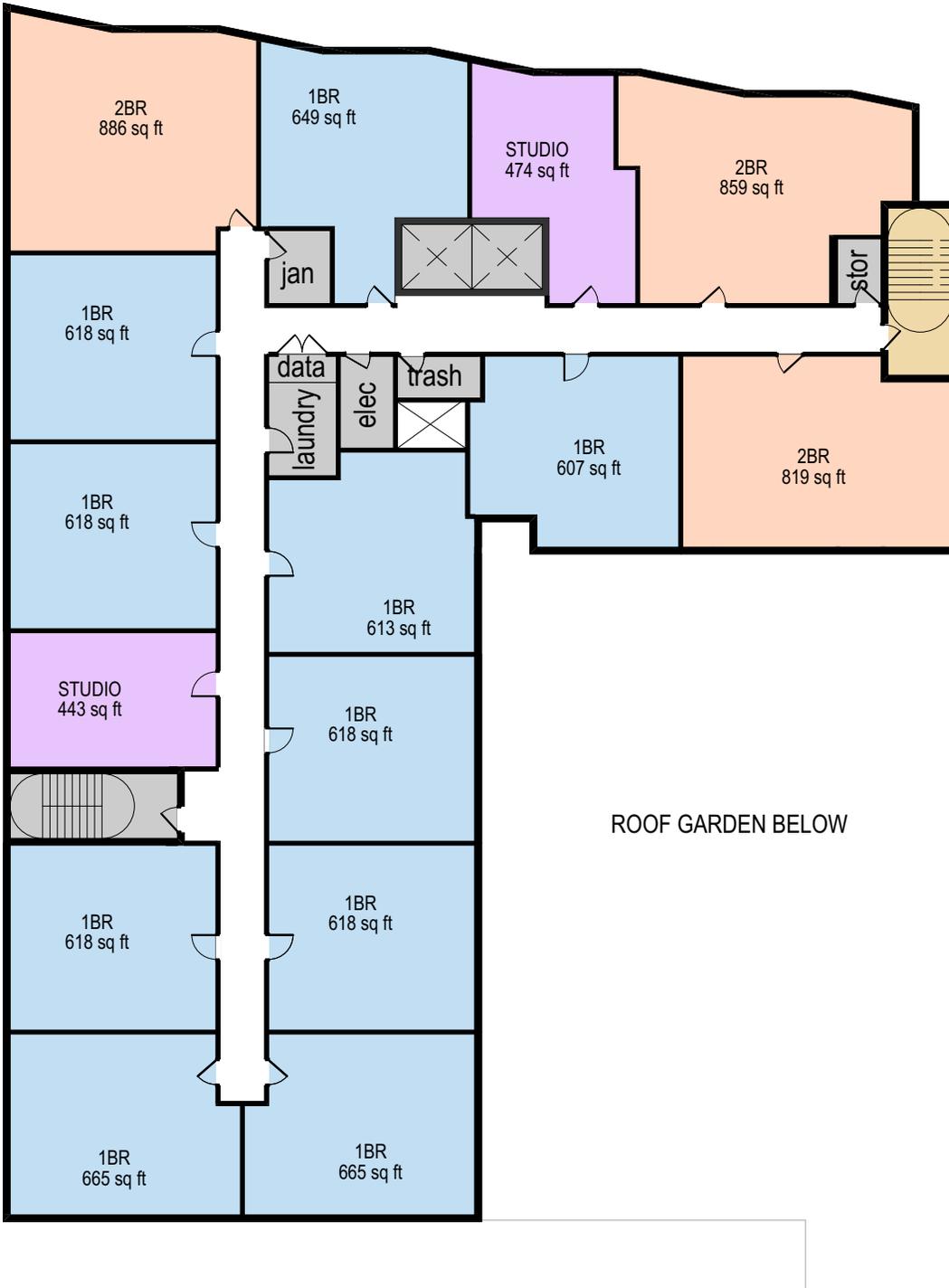

## Narrative Statement

### Lakefront Application

827-837 West Wilson Avenue

The 835 Wilson project, which will feature 73 affordable units for individuals age 55 and older. The project will have a welcoming entrance and innovative design and amenities, including: covered parking and large windows offering abundant natural light and views of nature. There will be a resident roof deck and garden that is inviting to residents and promotes people's health, happiness, and well-being. The deck and garden are intentionally sited next to (and connected to) a spacious, second floor community room that will be programmed with a variety of engaging resident activities such as zumba and yoga classes. Additional ground floor amenity space will include a management office, wifi business center for remote workers, and services/exam room.

The building will be financed with 4% low-income housing tax credits and the generous financial support provided by the site's neighbor, Lake View Towers (LVT). Note that LVT is not a co-op, but rather a residents association. Their residents' association is contributing nearly \$11,000,000 in proceeds from a loan refinancing to this project.

In addition to the amenities described above in the, 835 Wilson will feature the following unit amenities: handrails and pull cords, a view of the roof deck and garden for 28 of the units, central AC, vinyl plank flooring except for ceramic tile in the bathrooms, cultured marble countertop in the bathroom and plastic laminate in the kitchen, blinds, and internet access.

In general, our project design will embrace aging in place design guidelines for independent living in multifamily buildings. These include the use of low-slip flooring, accessible furniture, user-friendly door handles, and other features that support the overall goal of extending and enhancing the independence of all residents.

The mixed-income project will offer Studio, 1BR, and 2BR units for a 55+ elderly population. 835 Wilson will welcome residents from three distinct income tiers - 30%, 60%, and 80% AMI - into energy efficient, high quality affordable housing.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, and the requirements for an application in accordance with the Lake Michigan and Chicago Lakefront Protection Ordinance, specifically Section 16-4-100(c), please be informed that on or about June 8, 2020, the undersigned will file an application for a change in zoning from B3-5 Community Shopping District to B2-5 Neighborhood Mixed-Use District and an application for approval under the Lake Michigan and Chicago Lakefront Protection Ordinance, on behalf of Brinshore Development, LLC, an Illinois limited liability company, for the property located 827-837 West Wilson Avenue, Chicago, Illinois and described as follows:

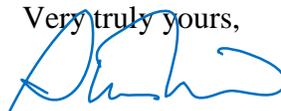
