Data time period: November 1 - November 30, 2019 & 2020

Summary

- In November 2020, 102 young people were processed at JISC, which is 52 percent fewer than the 214 during the same period in 2019.
 - 12 young people were released to an adult and 4 were referred to the new City-funded case management agency, Lawndale Christian Legal Center (LCLC), which started providing services on site at JISC in November.
- Motor vehicle theft (27) and Drug abuse violations (25) were the most frequent JISC-processed arrest charges in October 2020.
- Compared to November 2019 there were decreases in the proportion of youth released to adult (12% of all instances or 12 cases in 2020 and 21% of instances in or 46 cases in 2019) and youth referred to the city-funded case management agency, Lawndale Christian Legal Center (LCLC) (4% of instances in 2020 and 17% of instances or 37 cases in 2019).
 - 30% of youth were diverted, or informally station adjusted (released to an adult or referred to services in lieu of court).
- The community areas with the most JISC processed arrests were Humboldt Park (23 youth) and West Garfield Park (9 youth).
- November 2019 and 2020 saw similar trends of most youth having few prior arrests (32% of young people had no prior arrest in 2020 and 2019). For the year following their youth who were arrested and processed at JISC in 2019, 186 youth (59%) were not re-arrested in the following year.
- The most common arrival hours in November 2020 were 12-2pm and 4-11pm. Additionally, JISC arrivals were most common Monday, Tuesday, Thursday, and Friday and saw a slight decrease on Saturdays and Sundays.
- Across the city for all JISC districts during both the 2019 and 2020 periods, most youth were in transit (between arrest and arrival at JISC) for less than 2 hours, with 30-119 minutes being the range of most common transit times.
- There were no arrests indicating that an Alternate Disposition higher than the calculated disposition was used, and 3 arrests with lower alternate dispositions. In other words, CPD detectives did not use discretion in imposing a stricter disposition than the one the screening tool recommended and the disposition for three youth was adjusted to a lower status. (The Office of the Inspector General's report referred to these alternate dispositions as "overrides".)

Note: CPD may pull data for these reports on more than one day which could result in slight data inconsistencies because of expunged records. For example, 99 youth are recorded in the demographics section but 102 in disposition section. This discrepancy is because three arrests were expunged during the process of analyzing the data.





3. Disposition Data

Of the most common disposition outcomes in November 2020, the most prominent were court referrals (36% or 37 referrals) and released to adult (12% or 12 cases). 30% of youth were diverted, or informally station adjusted (released to an adult or referred to services in lieu of court). 19 more young people were detained this month as compared to 13 in October 2020 and 2 more than November 2019. Meanwhile, compared to November 2019 there were decreases in the proportion of youth released to adults (12% of all instances or 12 cases in 2020 and 21% of instances in or 46 instances in 2019) and youth referred to SGA case management (0% of instances in November 2020 and 17% of instance or 37 cases in 2019).

In November 2020, the 11th and 01st districts were the most common arrest location for youth processed at JISC as compared to the 08th and 11th districts in 2019. All districts experienced a decrease as compared to 2019 and the 10th and 08th districts saw the most significant decrease in location of youth arrests who result in being processed at JISC, with approximately 88% reductions in district 08 and 75% reductions in district 10.




November 2019 and 2020 saw similar trends of most youth having few prior arrests (32% of young people had no prior arrest in 2020 and 2019). For the year following their youth who were arrested and processed at JISC in 2019, 186 youth (59%) were not re-arrested in the following year.






6. Movement Time By District

While a youth's movement time before arriving at JISC is the responsibility of CPD patrol officers in each district, this analysis provides context for potential broader changes with youth interactions across CPD. Across the city for all JISC districts during both the 2019 and 2020 periods, most youth were in transit (between arrest and arrival at JISC) for less than 120 minutes, with 30-119 minutes being the most common.




In November 2020, Districts 01 and 11 have the most youth who were transported for the longest time with 3 youth arrested in District 01 and 5 youth in District 11 whose movement was more than 300 minutes and District 01 with 6 youth whose movement was more than 180 minutes (3 hours).

7. JISC Alternate Disposition Data Analysis Point

There were no arrests indicating that an Alternate Disposition higher than the calculated disposition was used, and 3 arrests with lower alternate dispositions. In other words, CPD detectives did not use discretion in imposing a stricter disposition than the one the screening tool recommended and the disposition for three youth was adjusted to a lower status. (The Office of the Inspector General’s report referred to these alternate dispositions as “overrides”.) The field used to extract the above information was recently created and only had no value ("Null") or "N" indicating no alternate disposition was made.
