III. Review of CIAC Community Engagement Subcommittee Recommendations

- Discussion of overall CCMHE Community Engagement

- Mayor's Office introduces idea of incorporating community engagement into all subcommittees by dissolving the Community Engagement Subcommittee and assigning individuals and requirements dedicated to community engagement into the other subcommittees.
- Mayor's Office opens for feedback
- Co-Chair Marco: believes this is a good idea and makes sense
- Other members agree that it is important that community engagement is an integral part of all work conducted by CCMHE and this plan makes sense
- James: Wants to ensure coordination between other subcommittees regarding community engagement.
- Concern around what the process and procedure will be to ensure other subcommittees are doing community engagement
- Kate (MO): By-laws will be used to address this and establish standards and requirements. A standard operating procedure will also be created.
- Discussed idea of a point person being assigned to each subcommittee that is responsible to overseeing that subcommittees community engagement efforts. All of the community engagement point persons can meet regularly.
