III. CDPH Update – Alisha Warren

A. MH Clinics

- Our MH clinics are expanding services and hours of operations
 - Beginning 7/2021 we extended our services to children/adolescents' services (psychiatric evaluations, medication monitoring and individual therapy for children as young as sic years of age via telehealth and in person at our Greater Lawn site
 - We've extended hours of operation at our Greater Lawn site (Tues & Thurs from 8:30a-8:30p). Beginning the week of 8/23, our North River site will have extended hours on Wed & Thurs from 8:30a-8:30p.
 - We plan to have all our MH clinics open two nights a week until
 8:30p as a phased rollout

B. TICC Grantees

- a. We are on track to serve 20k residents in 2021
- C. MH Stigma Campaign "Unspoken"
 - a. Campaign rollout will be launching with our microsite within the next couple of weeks with different marketing material across the city on trains, busses, bus stops. etc.
- D. Alternate Response Program (Care Team)
 - a. Set to launch 08.30.2021
 - i. Team is currently in training
 - ii. Staff includes: CIT, Community paramedics, and MH Crisis Clinicians
 - iii. Plan to serve the following areas during this pilot: Auburn Gresham, Chatham, Lakeview, and Uptown community areas

Questions

 Marco Jacome: what is the referral coordination for clients/participants for partnerships with social service organizations

- (Alisha): location may be a barrier but we will work to coordinate our efforts with partners within close proximity to the location of staff/incident
- Unknown: request for "unspoken" campaign link
 - (Alisha): campaign has not been launched yet but can provide once it is
- Dr. Burnett-Ziegler: when will we discuss budget priorities; status of town hall meetings and community engagement sessions
 - (Dr. Jasmin): there are town halls planned, but nothing has been scheduled
- Elliot: In reference to Alternate Response Teams launching on 8/30, I'm curious about other pilot programs that are being developed and their progress
 - (Alisha): we will be collecting data over the next couple of months from the first model that launch. The other two models are different because they don't involve a CIT officer. We're hoping to collect data from the second two models sometime in the fall.
- Elliot: How will collected data determine the rollout of pilot
 - (Alisha): we will have a program evaluator who will be working on this data collection; we will also be engaging with the community to determine the course of the pilots
 - (Dr. Jasmin): it'll be a good idea to bring evaluator to subcommittee meetings to explain collection of data
 - (Harold Pollack): we'd be happy to share our study of instruments from the first responder qualitative interviews that we've put together at U of C
- Harold: what kind of training is the CARE team receiving on individuals with intellectual and developmental disabilities who they may encounter with these interactions
 - (Alisha): we have a 3-hour training this afternoon covering those areas
- Elliot (Alex Heaton joined meeting to respond to this question): what is the specific data that we'd be collecting for the pilots
 - (Alex): we're looking at data from CPD, CFD, CDPH and OEMC
 - all first responder agencies and CDPH
 - frequency of contacts with 911
 - individual's experience with contact
 - what happens in follow-up
 - (forthcoming) a component that includes interviews with the individual and members of the community – a lot of data streams
 - Regular analysis and larger evaluations
- Elliot: regarding community engagement, will it be an opportunity for people in the community to participate in determining the data points/research process

- (Alex): we will be using CCMHE for community engagement to initiate some of our variables and hoping to get feedback from members on the various committees on what they'd like to see
- (Kate): also added that this was discussed in the Deflection & Diversion subcommittee regarding focus groups, and we will be focusing more on that next week
- (Elliot): who will be developing focus groups I've been trying to connect w/Dr. Saafir and have been unsuccessful
- (Kate:) the focus groups haven't been developed yet due to answering the OMA questions
- James Burns: asked about connecting with Alisha/Matt regarding anti-stigma campaign to provide feedback before it's rolled out
- Kate: due to a couple of the co-chairs being on vacation and recognizing Officer
 French's wake, we're pushing the rest of the agenda to the next meeting
 - DC Ursitti will be presenting CIT policies at every meeting throughout the rest of the year, I'll provide dates soon
- Harold Pollack: I'd love to see more discussion about what exactly the coresponders do beyond helping to manage a specific incident more safely and humanely providing effective follow-up
- Dan Esperanza: can we create a brief, crisp one-page job descriptive outline for each subcommittee; is this the subcommittee that reviews grants/RFP's that went out; regarding the data related to the grants that went out to CBO's, how does that relate to MH Safety Net subcommittee – what exactly is this group charged with
- Kate: there's a lot of work being done behind the scenes and we're looking to change the subcommittee format, working to ensure that everyone's viewpoint is being inputted; we're working to have a better answer by the end of the year
