To Whom It May Concern,

In solidarity with Southeast Side residents, the board of Chicago Audubon Society vehemently opposes the relocation of Reserve Management Group's large metal recycling facility to the Southeast Side. In 50 years of conservation work across the Chicago Region, Chicago Audubon Society has come to recognize the importance of a healthy, clean environment for both people and nature. This proposed recycling operation jeopardizes the health of residents, wildlife, and ecosystems that call the Southeast Side home.

Industrial operations should not be put before the health of people and the environment. Due to a long history of environmental racism and irresponsible industry, the Southeast Side already bears disproportionate public and environmental health burdens. The negative impacts of air pollution on human health are well-documented, but research indicates airborne contaminants like those released from this type of operation can negatively impact entire ecosystems. The United States EPA documents the type of cumulative impacts that can build up in an ecosystem in both plants and animals, increasing in toxicity and concentration as they move up the food chain. The Southeast Side is still recovering from a long history of abuse and dumping by industry, and City administrations that failed to protect communities and the environment. Millions of dollars and countless staff and volunteer hours from landowning agencies to nonprofits have gone into restoring Southeast Side wetlands, prairies and woodlands to health. A large portion of that time and funding goes toward remediation to address decades of soil and water contamination in the region's only remaining marsh habitat.

The proposed location of the RMG facility is downriver, upriver, and next door to schools and homes, but also to places like Indian Ridge Marsh, where immense effort and funding (both private and public) has gone toward creating a safe, welcoming outdoor experience. As rare birds, residents and travelers alike flock to newly restored parks and natural areas, it is paramount that the City do everything in its power to keep these areas safe and welcoming. Harmful and noxious emissions from a notorious polluter with a foul track record for violations jeopardize this vision. The City has a chance to change the course of history on the Southeast side by protecting Black and brown Southeast Side residents as it protects North side residents, and to protect our communities, environment, and our investments in green space and recreation.

RMG's track record at their Lincoln Park General Iron location does not inspire confidence that a safe, environmentally responsible company is moving to the Southeast Side. We are asking the City to take the right and responsible course of action and deny the permits that would allow RMG to operate on the Southeast Side.

My name is Rev. Matthew Zemanick and I am a resident of Chicago's 35th Ward. For three years I served as Pastor of Lebanon Lutheran Church in Chicago's 10th Ward. Currently, I work with the Southeast Environmental Task Force. I am writing these comments because I believe the City of Chicago must deny RMG/GII LLC a permit to operate a large recycling facility in order to protect the health of the 10th Ward - particularly George Washington High School students and residents who live in close proximity to the proposed location. The application RMG/GII, even beyond the deficiencies CDPH recognized, does not indicate a Large Recycling Facility can exist in a community overburdened by pollution.

I am particularly concerned about the compounding effects of Particulate Matter emissions by the facility and truck traffic going in and out of it. Firstly, no application material nor City regulation place limits or requirements for Large Recycling facilities on PM2.5. This is smaller PM that both the US EPA & World Health Organization (WHO) recognize as more dangerous than PM10. Tenth Ward residents do not know the ambient PM2.5 levels in their community because it is my understanding that none of the air monitors are calibrated in a way to detect these dangerous materials, most notably the air monitor at GWHS.

Furthermore, PM10 is already a problem in the 10th Ward. In RMG/GII's own application (V-15) notes that background concentration at GWHS, per the air monitor located there, is 77µg/L. Both the WHO and the European Union Environmental Protection Agency recognize concentrations above 50µg/L as beyond both hourly and annual limit values, which are set to protect human health. This is because PM10 exposure is linked to lower life expectancy, higher cancer rates, asthma, aggravated COPD symptoms, and pulmonary fibrosis among other dangerous health conditions. By RMG/GII's own estimation, their PM10 emissions could create an environment where the background PM10 in and around GWHS is as high as 106µg/L.

This evidence alone is enough for Dr. Allison Arwady to exercise her legal duty as Chicago's Public Health Commissioner to protect the health of Chicago residents and prevent RMG/GII from operating a city block away from public schools, Rowan park, and a residential neighborhood by denying them their permit to operate a large recycling facility.

Additionally, it is the duty of the City per the agreements it makes with the US Department of Housing and Urban Development to receive block grants under the Fair Housing Act and 1974 Housing and Community Development Act to foster integration and equitable development. The move of GII from Chicago's majority White Lincoln park neighborhood with an average household income of over \$108,000/yr to the majority Hispanic[sic] East Side neighborhood with an average household income of just under \$46,000/yr will create further disparities in income, home value, racial make-up, and health outcomes between these communities. If GII is not safe enough for Lincoln Park, why is it not safe enough for the East Side?

I should note that during the duration of community engagement with regard to GII's relocation to the 10th Ward the City has engaged in civic gaslighting. Multiple City communiques have claimed "this is not General Iron, this is RMG." The fact of the matter is, the Labkon family retains influence with RMG's operation of its subsidiary named General Iron Industries LLC (GII LLC) because they retain a large minority stake in the

company. This is the name of the company applying for a Large Recycling Permit on the application itself. These claims are insulting to the intelligence and dignity of Chicago residents. These claims are more insulting because both GII and RMG have violated multiple City, State, and Federal regulations over the course of their operations. Over the course of this process the City has refused to consider both GII & RMG's poor record of regulatory compliance as a factor in the permitting process. How can we take their estimations and information in their permit application in good faith?

Finally, I appeal to you as a Pastor in the Evangelical Lutheran Church in America. While serving in a parish in Chicago's 10th Ward, I noticed that in ~90% of the households under my care there had abnormal health conditions such as rare cancers, aggressive COPD, asthma, and rare developmental disabilities. Many of my colleagues in parishes of comparable size did not encounter this level of disease in their parishes, notably in wealthier, whiter parishes.

A healthy living environment should not be a luxury good. It is a human right. Yet, in the City of Chicago, especially if this permit is approved, this will not be the case. In the City of Chicago clean air is a luxury good afforded to wealthy, white communities, at the expense of working-class communities of color. This may not be your intention but it is certainly the impact of decades of policy. We must turn the course. We must protect public health. We must uphold landmark Civil Rights legislation like the Fair Housing Act to undo the harm our City has caused to BIPOC (Black & Indigenous People of Color) Communities. The City of Chicago, particularly our Department of Public Health and its commissioner Dr. Allison Arwady, must exercise its legal duty to protect the health of Chicago residents from the dangers of air pollution, particularly during a global pandemic caused by a dangerous respiratory virus and DENY THE PERMIT.

Our concerns regarding the RMG Expansion fall into the two categories listed below along with the corresponding deficiencies listed in the Chicago Department of Public Health Application Deficiency Letter:

• Traffic Pollution:

- 11. Pursuant to paragraph 3.9.13.2 of the Rules, provide a stacking plan of all trucks and vehicles during the Facility's peak AM and PM traffic hours.
- 12. Pursuant to paragraphs 3.9.13.4 to 3.9.13.7 of the Rules, provide a traffic study in conformance with the requirements of said paragraphs. A traffic study was previously submitted to CDPH for initial review but was not included in the Application.

• Environmental Pollution:

- 33. Pursuant to 3.10.11 of the Rules, revise the hours of operation, taking into consideration the restrictions imposed under the IEPA construction air permit ID No. 031600SFX ("IEPA Air Permit"). For example, the IEPA Air Permit limited facility vehicle traffic to 14 hours per day on weekdays and 12 hours per day on weekends. These hours conflict with the 24/7 operation proposed in the Application. Other conflicting hours between the IEPA Air Permit and the Application include the non-ferrous system operation hours and barge loading hours.
- 34. Pursuant to 1-4-2530(I), provide an odor control plan that addresses the potential odors at the Facility. Such plan shall include, but may not be limited to, the following:
 - A. An inventory of odor-emitting activities;
 - B. The location, time, and duration of each odor-emitting activity;
 - An odor mitigation plan that includes specific administrative and/or engineering controls and best management practices for each odoremitting activity;
 - D. Routine odor inspections around the Facility and nearby adjacent Sensitive Areas; and
 - E. Protocols for investigating odors discovered during routine inspections or as reported in an odor complaint.

We are completely aware that our area is surrounded by industrial properties and is a proper space for this business and regardless of the company or product, we will do everything necessary to keep our residents safe from traffic, environmental and chemical pollution. There is new technology that <u>must</u> investigate and procure. It would prove their interest in being a good community partner.

RE: Comments on General III, LLC Large Recycling Facility Application

To Whom It May Concern:

Thank you for the opportunity to comment on the request by General III, LLC's ("GIII") for a Class IVB Large Recycling Facility permit, proposed for their property at 11600 S. Burley Avenue in Chicago. The Nature Conservancy is committed to conserving the resources for sustaining life on Earth, and we are called to take particular care where communities already carry a heavy environmental burden. From our science-based analyses and experience with the communities of the Calumet River, we urge the Department to reject this permit application.

The Conservancy bases our determination in part on our evaluation of community vulnerability to impacts related to climate change. Our analysis, called the Chicago Greenprint, identifies all communities along the Calumet River (from Lake Michigan to Lake Calumet) as having especially high vulnerability to poor air quality. This matter is well-documented, given the many environmental justice issues local activists have raised in the Southeast Side. Our analysis utilizes publicly accessible data from government sources related to air quality, filtering the results by U.S. Census data on income and concentration of youth with high vulnerability.

One of the Conservancy's partnerships on the Southeast Side works with community volunteers, including families with young children, to engage them in stewardship of the valuable natural areas at Chicago Park District sites such as Big Marsh and Indian Ridge Marsh. Among our goals are to foster the many health benefits of engagement with nature and the outdoors in participants. However, these sites are within one mile of the proposed GIII facility. We also have helped to fund restoration programs at Eggers Grove Forest Preserve and William Powers State Recreation Area, both of which are similarly close and generally downwind of the proposed facility.

The Conservancy has a history of investment in Southeast Side natural areas and communities. Since 2015, we have led a coalition that has brought federal funding to restore habitat at the parks mentioned above totaling over \$875,000. These investments have had a significant impact on improving the quality of

Additional air pollution from the proposed GIII operation would only build on the existing risk demonstrated by our analyses, leading to concerns about the ongoing risk to the people working to manage and maintain these spaces for the community.

We are concerned that awarding the permit to GIII will jeopardize community residents seeking to improve their health at these important local natural areas, adding new risks to a community that is already overburdened with industrial air quality issues.

We appreciate and support the Department's deficiency letter to GIII from December 23, 2021. However, the issues with the permit application go well beyond the gaps in the information supplied by GIII. It is clear from many data sources, including our own, that the 11600 Burley Ave. location – and the Southeast Side in general – is an inappropriate location for a large recycling facility. We encourage the Department to deny this permit.
