Notice to Building Owners:

The Chicago Department of Buildings requires that all Elevator Inspectors who perform third-party elevator Annual Inspection Certification (AIC) program inspections maintain an active State of Illinois elevator inspector license. Furthermore, the individual inspector must either be employed by or be a sole proprietor of an Illinois-licensed elevator inspection company listed above and maintain proper insurance coverage in conformity with state guidelines.

Notice to Elevator Inspection Companies:

Individuals wishing to become an "Authorized Technician" for the purpose of performing third-party elevator Annual Inspection Certification (AIC) inspections are required to become an Illinois Licensed Inspector for elevators.
