SCOPE OF SERVICES

The Contractor must provide Shipyard Services for repair work (not rehabilitation work to like new condition) necessary to comply with the American Bureau of Shipping (ABS) standards, and in accordance with, but not limited to these Detailed Specifications.

A. Project Description

The description of the Project described herein is intended to be general in nature and is not be construed to be a complete description of the Project or a limitation on the Services to be provided hereunder.

B. Role of the Contractor in the Project





On January 8, 2013, the Department of Water Management met with the sole source board and was conditionally approved, pending additional request for quotes from other shipyard company's, to enter into a sole source contract with Bay Shipbuilding to perform our mandated five (5) year inspection/survey. Additionally, in an effort to meet the board's request, DWM identified and contacted the following shipyard company's and received the following responses:

Chicago Dry Dock located at 106th & Torrence in Chicago, IL – no response to our phone calls;

Basic Shipbuilding in Escanaba, MI – no response by date requested;

Great Lakes Dredge & Dock in Illinois could not provide services requested:

Independent Marine Associates in Lemont, IL – no response;

DWM would also like to reiterate with our past experience in identifying, contacting and working with other shipyards and dry docks located in the Great Lakes region the following concerns/disadvantages that occurred:

- Previous non-compliant work performed had to be redone by Bay Shipbuilding Company;
- Great Lakes Dredge and Dock located approximately 640 nautical miles from Chicago would cost the city more in round trip costs versus a round trip to Bay Shipbuilding;
- Qualified Marine Pilots would have to be hired and brought on board as the Tugboat would have to navigate restricted waterways such as the Detroit River:
- Other full service, A.B.S. compliant shipyards located in the United States, such as National Steel in San Diego, CA and Bath Iron Works located in the state of Maine were not considered due to the logistics of transporting the tug boat to the east or west coast;
