**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The City Council finds that the areas described in Section 2 through 4 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

**SECTION 2.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.16), which was previously deleted as shown in the Journal of Proceedings of September 14, 2016 at page 31390, with the following underscored text:

4-60-022 (47.16)      On Damen Avenue, from Addison Street to Grace Street

**SECTION 3.** Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (47.57), which was previously deleted as shown in the Journal of Proceedings of March 16, 2016 at page 20040, with the following underscored text:

4-60-023 (47.57)      On Southport Avenue, from Byron Street to Berteau Avenue.

**SECTION 4.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.39), which was previously deleted as shown in the Journal of Proceedings of November 18, 2015 at page , with the following underscored text:

4-60-022 (47.39)      On Lincoln Avenue, from Grace Street to Irving Park Road

**SECTION 5.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.30), which was previously deleted as shown in the Journal of Proceedings of September 24, 2015 at page 14021, with the following underscored text:

4-60-022 (47.30)      On Irving Park Road, from Ravenswood Avenue to Damen Avenue

**SECTION 6.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.18), which was previously deleted as shown in the Journal of Proceedings of May 6, 2015 at page 108491, with the following underscored text:

4-60-022 (47.18)      On Damen Avenue, from Irving Park Road to Berteau Avenue

**SECTION 7.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.63), which was previously deleted as shown in the Journal of Proceedings of January 21, 2015 at page 101868, with the following underscored text:

4-60-022 (47.63)      On Western Avenue, from Berteau Avenue to Montrose Avenue

**SECTION 8.** Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (47.46), which was previously deleted as shown in the Journal of Proceedings of September 10, 2014 at page 87961, with the following underscored text:

4-60-023 (47.46)      On Montrose Avenue, from Ravenswood Avenue to Damen Avenue

**SECTION 9.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.35), which was previously deleted as shown in the Journal of Proceedings of April 2, 2014 at page 77633, with the following underscored text:

4-60-022 (47.35)      On Lawrence Avenue, from Ravenswood Avenue to Damen Avenue

**SECTION 10.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.34), which was previously deleted as shown in the Journal of Proceedings of April 2, 2014, with the following underscored text:

4-60-022 (47.34)      On Lawrence Avenue, from Ashland to Ravenswood

**SECTION 11.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.2), which was previously deleted as shown in the Journal of Proceedings of January 15, 2015, with the following underscored text:

4-60-022 (47.2)      On Addison Street, from Damen Avenue to Leavitt Street

**SECTION 12.** Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (47.70), which was previously deleted as shown in the Journal of Proceedings of September 10, 2014 at page 87961, with the following underscored text:

4-60-023 (47.70)      On Wilson Avenue, from Ravenswood Avenue to Damen Avenue

**SECTION 13.** Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (47.35), which was previously deleted as shown in the Journal of Proceedings of July 24, 2013 at page 58054, with the following underscored text:

4-60-023 (47.35)      On Lawrence Avenue, from Ravenswood Avenue to Damen Avenue


**SECTION 14.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (47.12), which was previously deleted as shown in the Journal of Proceedings of January 17, 2013 at page 45330, with the following underscored text:

4-60-022 (47.12)      On Clark Street, from Byron Street to Berteau Avenue

**SECTION 15.** Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (47.30), which was previously deleted as shown in the Journal of Proceedings of January 17, 2013 at page 45343, with the following underscored text:

4-60-023 (47.30)      On Irving Park Road, from Ravenswood Avenue to Damen Avenue

**SECTION 16.** This ordinance shall be in full force and effect from and after its passage and publication.
