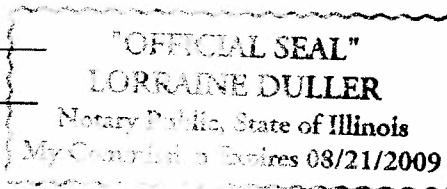



It was agreed that two plies of SBS modified bitumen would be installed as the vapor retarder. Phase "B" Cost Proposal includes material and labor to install the vapor retarder and the base sheet omitted from the Phase "A" Cost Proposal.

Estimated duration of this Project is (1) one Weeks.


