Please describe the major features of this project.

The scope of work on this project includes installing a protective railing in the interior of the station, replacing the north and south facades with new glass and metal curtain walls, adding environmentally friendly LED lighting, and replacing the current roof.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

The current facades and roof at the State/Lake loop elevated station were installed in 1968 and 1913 respectively and consist of corrugated metal, plywood, and plexiglass that are all in need of replacement and are a safety hazard for CTA customers. A lack of funding in the past has delayed this work. CDOT owns, and is responsible for capital improvements to downtown loop stations. CDOT has found a TIF funding source that would pay for the repairs but expires the last day of 2008. This means that all construction bills need to be paid by the end of the 2008 year. Procurement of materials on this project involves a long lead time. Owing to the emergency nature of the work, the timing, procurement and funding restrictions involved, CDOT feels that it would not be feasible to perform this work through a traditional bid process.

3. If the project is a one trade project, please provide additional explanation of why it would be in the city's best interest to do the project under JOC:

More than one trade will be involved.

4. If it is anticipated that over 25% of the project will consist of Non-prepriced items, please provide an explanation on why JOC should be used.

It is not anticipated to contain more than 25% Non Pre-priced.

There are no existing term agreements currently in place that would cover this scope of work and trades involved.


