MEETING MINUTES

PERMIT REVIEW COMMITTEE COMMISSION ON CHICAGO LANDMARKS

The Permit Review Committee (PRC) met on June 7, 2018, at 1:55 p.m. The meeting was held at 121 N. LaSalle St., in Room 201-A.

The following projects were reviewed by the PRC:

1. 1246 N. Astor **43rd Ward**
Astor Street District

Proposed exterior and interior rehabilitation including a new, one-story rooftop addition with deck.

Action: Approved unanimously with the following conditions:

1. Samples of the proposed cladding for the rooftop enclosure shall be submitted for Historic Preservation staff review and approval prior to order and installation; and,
2. The project as proposed has outstanding zoning issues that will need to be addressed before the pending permit application can be approved. Should the project, for which the Permit Review Committee issued a preliminary approval, be substantially altered, the project will need to be reviewed anew by the Permit Review Committee. The Commission takes no position regarding any requested zoning variances/adjustments or other requests relative to the zoning code requirements.

2. 1958 W. North **2nd Ward**
Milwaukee Avenue District

Proposed interior and exterior renovation including partial window replacement, new storefronts, and partial construction of a new flat roof corner turret and pressed metal cornices based on historic documentation.

Action: Approved unanimously with the following conditions:

1. Partial reconstruction of the missing corner turret is approved as proposed;
2. Samples of any replacement stone, patching, and any new masonry and mortar shall match the historic in size, color, profile, texture, and type and shall be reviewed and approved by Historic Preservation staff prior to order and installation;
3. The new windows shall match the existing window in size, glass size, operation, muntin arrangement, and muntin size. The windows can be simulated divide lite windows as proposed. Existing and proposed details of exterior profiles shall be submitted with the permit application;
4. The storefronts shall have a dark factory-applied finish and all glass will be clear vision glass;
5. No exterior lighting is approved with this submittal. The design, materials, locations, and installation details shall be reviewed by Historic Preservation staff when available;
6. No signage is approved with this submittal. Any proposed signage shall be permitted separately and reviewed and approved by Historic Preservation staff prior to order and installation; and,
7. A report by a licensed structural engineer addressing the proposed interior structural removal and new interior wall and floor openings, relative to how the building should be braced and protected during such removal and reconstruction, shall be submitted for Historic Preservation staff review and approval, as part of the permit plans. The recommended measures, sequencing, and protections shall be incorporated in the structural and architectural drawings

3. 1425 W. Fullerton

2nd Ward

Fullerton State Bank Building

Proposed rehabilitation and conversion of existing 3-story bank building into an 8-unit residential use including façade restoration and new 4-story side addition and a 1-story rooftop addition.

Action: Approved unanimously with the following conditions:

1. Masonry repair scope of work shall be indicated in the permit application plans. Samples of the exterior wall materials for the additions including the new brick, stone base, and metal color/finishes shall be reviewed and approved by Historic preservation staff prior to order and installation;
2. The proposed 1-story rooftop addition, is approved as proposed. Any rooftop elements such as landscaping in built-in planters, trellises, or code-required railings shall be set back and low enough so as not to be visible from the public rights-of-way;
3. A report by a licensed structural engineer addressing how the historic facades to remain should be supported, brace, and protected, in-situ, during the construction of the new third floor, side addition,

and rooftop addition shall be included on the permit plans. The recommended measures, sequencing, and protections shall be incorporated in the structural and architectural drawings;

4. The proposed new vinyl windows are not a compatible match to the dimensions and profiles of the existing steel windows and are not approved. Replacement windows shall be aluminum or steel and shall more closely match the historic windows in size, glass size, operation, mullion and muntin arrangement, and size. The windows may be simulated divided lite windows. Existing and proposed details of exterior profiles shall be submitted with the permit application;
5. The aluminum panels proposed to clad the rooftop addition shall be dark gray so that it better recedes visually. Staff shall review and approve all material samples prior to order and installation; and,
6. The Commission takes no position regarding any variations and/or adjustments relative to the zoning code requirements.
