# MEETING MINUTES

## PERMIT REVIEW COMMITTEE COMMISSION ON CHICAGO LANDMARKS

The Permit Review Committee (PRC) met on November 1, 2018, at 1:15 p.m. The meeting was held at 121 N. LaSalle St., in Room 201-A.

The following projects were reviewed by the PRC:

**1. 1060 W. Addison** **44<sup>th</sup> Ward**  
**Wrigley Field**

Proposed revised design of the northwest and southeast elevations and roof deck areas.

**Action:** Approved unanimously with the following condition:

1. The proposed work to the northwest corner of the ballpark eliminating the Player's Family Lounge are approved as shown on Populous drawings dated 9/20/18. Enlarged details of the brick piers shall be included in the permit plans;
2. The new elevator enclosure at the southeast corner upper deck, consistent with the approved Master Plan, is approved. Enlarged dimensioned plans, elevations, cut sheets etc... of the two new elevators proposed in the bleachers, the new elevator on the southeast corner upper deck, as well as for the proposed changes in the elevator enclosure at the upper deck near the main gate shall be provided as part of the permit application. The size and height of all elevator enclosures must be as minimal as possible;
3. The proposed beige color, consistent with the previously installed elevator enclosures at the upper deck, is approved for the upper deck enclosures. The proposed green metal paneling is approved for the bleacher elevator enclosures, consistent with the previously installed elevator enclosures at the bleachers;
4. Enlarged details of the proposed replacement of the existing chain-link fencing at the upper deck shall be included in the permit plans. The cross fencing panel design of this fence shall match the pattern

- of the cross fencing panels for the railings at the roof deck and mezzanine levels;
5. The 9” tall signs for the “Cubs Store” and “Club & Suite Entry” along the southwest corner are approved as proposed. Dimensioned details of the “Wintrust” sign above the southeast gate shall be included as part of a sign application permit;
  6. The 6’-deep balconies at the Stadium Club along the east elevation, south of the bleachers, are similar in appearance to the balconies shown in the approved Master Plan and are approved as proposed;
  7. Prior to the permit application, enlarged details of the metal cladding and window system for the Stadium Club enclosure that will match as closely as possible for the green metal framing and opening proportions and profiles of the ballpark shall be submitted for review and approval by Historic Preservation staff;
  8. A roof plan of the Stadium Club enclosure shall be included in the permit plans to ensure that any rooftop equipment is set back to be minimally visible from the public rights-of-way;
  9. All materials, colors, and finishes to be a continuation of those approved in previous phases of work; and,
  10. All conditions of approval from the previous review of the overall master project will continue to be applicable.

**2. 4649 N. Broadway**

**46<sup>th</sup> Ward**

**Uptown Square District**

Proposed alterations of front façade of existing 2-story masonry non-contributing building including new windows, storefronts, and replacement of deteriorated exterior wythe of brick with matching brick.

**Action:** Approved unanimously with the following conditions:

1. As proposed, the exterior wythe of deteriorated brick will be replaced with new red brick matching the color, texture, and appearance of the historic brick, per the brick sample viewed on-site (McNeer Red); and,
2. As proposed, the existing terra cotta will be repaired and retained whenever possible. A reconstructed second floor sill and any required terra cotta replication is proposed to be glass fiber reinforced concrete (GFRC) to match the historic color, texture and reflectivity. Staff shall be notified to view and approve GFRC samples on-site prior to order and installation.

**3. 1848 N. Lincoln**

**43<sup>rd</sup> Ward**

**Old Town Triangle District**

Proposed rehabilitation of a raised, three-story building including a rooftop deck and access enclosures, rear addition, and construction of a new garage utilizing an existing curb-cut.

**Action:** Item was deferred at the request of the applicant; no action was taken by the Committee.
